This organization shall be called:

Article 11 "Object"

The object of this club shall be to provide, promote and supervise community recreation.

Artiele 111 "Membership"

A membership in this club shall consist of the immediate family group.

Article 1V "Officers"

- Section 1. The officers of this club shall be a President, Vice-President, Secretary and Treasurer.
- Section 2. The executive board shall consist of the officers and three other members one being the retiring president.
- Section 3. The duties of the officers shall be such as belong to their several offices in similar clubs.
- Section 4. All officers shall give written annual reports.

Article V "Meetings"

Section 1. The regular meetings of the club shall be held at 8 p.m. on the first Monday of each month.

Section 2. The annual meeting shall be held at 8 p.m. on the first Monday in January.

Article V1

The Constitution may be amended by drafting through the executive board and reading at three successive meetings and passing by two-thirds majority vote.

> By-Laws Article 1.

- Section 1. The membership of this Club shall be unlimited.

- Section 3. All adult members shall share in the work and responsibility of the club.

Article 11

- Section 1. Special meetings may be called at any time by the President.

Article 111 Duties of Officers

- Section 1. The President shall preside at all meetings of the club and act as Chairman of the Executive Board; shall sign all orders drawn upon the Treasury when approved by the Club and shall perform all other duties pertaining to the office.
- Section 2. In the absence of the President the Vice-President performs all the duties of the office.
- Section 3. The Secretary shall keep a true record of all business transacted at the meetings of the club and Executive Board; shall authenicate all acts and orders of the Club; conduct the necessary correspondence and give an annual written report.
- Section 4. The Treasurer shall receive all moneys and deposit the same in a bank approved by the Executive Board. All bills shall be presented and upon approval of the club be paid by check signed by the Treasurer and countersigned by the President. A full financial report shall be given at the annual meeting and when called for during the year upon a week's notice.
- Section 5. The Executive Board shall meet at the call of the President and act as an advisory board.

Article IV

- Section 1. Election of officers will be held at the annual meeting.
- Section 2. Officers shall be elected by secret ballot upon nomination A majority of the notes cast shall constitute an election.

Article V Dues & Finances

- Section 1. Dues shall be \$1.00 a year per membership.
- Section 2. Dues shall be payable at the first of the year or upon joining. Any new member will pay full dues for the current year.
- Section 3. No appropriation shall be made from the Treasury until it has been passed on by the Executive Board.

Article Vl

Roberts Rules and Orders shall be the authority on all questions not covered by the constitution and By-Laws.

Article V11

The By-Laws may be amended at any regular meeting of the club by a two-thirds vote of the members present and voting, providing the amendment has been submitted in writing and read at the preceeding meeting.
