Geraldine C. "Gerry" Thompson, Salem, was named today as Gov. Vic Atiyeh's new executive assistant.

Thompson fills the position currently held by Lee Johnson who has announced his resignation effective September 4. Johnson was Atiyeh's first executive assistant having held that position since December 1978.

Thompson, 42, currently is the vice president for marketing for Oregon Physicians Service-Blue Shield (OPS), Portland. She will assume the governor's office position before September 15. Her yearly salary will be \$55,416.

The new governor's assistant has worked for OPS since 1962.

In addition to her current position she has served for the firm as vice president and general sales manager, assistant vice president and manager of the southwest district, Salem branch office manager, and district services representative.

OPS is the second largest health insurance company in Oregon with over \$110 million in annual revenue. It is a not-for-profit organization which serves 450,000 Oregonians.

Prior to 1962 Thompson worked for Pacific Northwest Bell as a service representative in Newport, Corvallis, and Salem.

A native of Olympia, Wash., Thompson is a 1957 graduate of South Salem High School.
