**These two documents, one a Proclamation and the other an Executive Order, were prepared during the height of the grim tensions surrounding the presence of the Baghwan and the thousands of his followers. The Proclamation called for martial law in Jefferson and Wasco Counties and the Executive Order activated the National Guard. Both are extraordinary actions for any Governor to take but they represent the extent of the unrest among Oregonians and the real potential for disaster that could occur.**

**Because there would be an immediacy of action should there be a need to activate them I carried both at all times until the crisis passed. That came with the arrest of an escaping Baghwan and the breaking up of his cult. These papers traveled the state with me and even to foreign countries on some of my trade missions.**

**Fortunately for all of us there never became a need to sign them.**



EXECUTIVE ORDER NO. EO - 85 -

PUBLIC SAFETY EMERGENCY

WHEREAS, I find that riot, breach of the peace, and civil disturbance are or may be occurring and continuing in Central Oregon; and

WHEREAS, I find that police and law enforcement activities in Central Oregon, including the activities of all local police and peace officers, require the support and assistance of the Oregon National Guard to restore and secure peace and order and compliance with the law; therefore,

IT IS ORDERED AND DIRECTED:

By virtue of the authority vested in me as Governor by the Oregon Constitution and ORS Chapter 399, the Adjutant General, Oregon National Guard, shall order into active service for such period, to such extent and in such manner as the Adjutant General may deem necessary, all or any part of the Oregon National Guard in aid of civil authorities to protect life and property and to maintain peace and order and to restore and secure normal civil peace in Central Oregon.

P R O C L A M A T I O N

WHEREAS, I find that in Central Oregon, tumult, riot, breaches of the peace and forcible obstruction to the execution of law have lately and frequently occurred and are continuing; that the rights of people of the community have been unlawfully affected; that lawless groups are gathering with intent to offer violence to persons and property and forcibly to break and resist the laws of the State in said area; and

WHEREAS, peace officers in Central Oregon require assistance to restore peace and order and to secure compliance with the law; and

WHEREAS, by virtue of the authority vested in me as Governor by the Constitution and the statutes of this state, I have ordered into active service such part or all of the National Guard as The Adjutant General may determine to be necessary in aid of civil authorities to protect life and property and to maintain peace and order and to restore normal civil process in Central Oregon;

NOW THEREFORE, pursuant to ORS 399.065, I hereby declare Jefferson and Wasco Counties to be under martial law and admonish all citizens of the State and all persons within its territory and jurisdiction against aiding, countenancing, abetting or participating in any unlawful proceedings, and I hereby warn all persons engaged in or connected with any violence and obstruction of the laws to disperse and retire peaceably to their respective abodes, and to go about their legitimate, lawful pursuits immediately.

This declaration and warning are intended to maintain law and order and to protect and save the innocent, and I appeal to all sober-minded and peace-loving persons to cooperate loyally in the restoration of peace and quiet in Central Oregon.
