

As you begin what I assume is the emotional task of ending eight years at the State Capitol, I hope you will reflect on the progress the arts have made. The Oregon Arts Commission recognizes and appreciates the fact that you are responsible for our being here: we are all your appointees and thank you, both individually and collectively, for the trust you have displayed in us.

To show our appreciation and to publically acknowledge your support of the arts, we have directed Leslie Alexander, our acting director, to write an appropriate article for the Oregon Arts News, a publication that circulates through the State and region. We hope you'll particularly notice the last paragraph. Indeed, most of the time we see you, we're in the budget process and come with requests for a sizeable increase. When looking at overall state funding, we can be more appreciative of the growth Oregon has received under your guidance.

We are also aware that a portion of our gratitude is directed to Delores. Her continual presence at arts events and her unswerving support of the arts are noted and valued. As you leave office, we hope both of you carry positive memories of the growth of the arts in Oregon made possible by your steady support.



# Oregon Arts Commission Salutes Governor Atiyeh

By the time the next issue of Oregon Arts News is published, we will have a new Governor-elect. It is therefore fitting that the Commission pay tribute to the man who appointed the nine members of the Arts Commission, and has overseen its development during the past eight years: Governor Victor

Perhaps many citizens do not realize Governor Atiyeh's close ties to the arts. Visitors to the Capitol this summer were delighted to find carvings by one Victor Atiyeh, Oregon craftsman, featured in the Guild of Oregon Woodworkers exhibit. Mrs. Atiyeh was an Arts major at W.O.S.C., and their daughter and son-

in-law are professional artists.

During his eight years in an admittedly difficult financial time, the Governor has protected the Oregon Arts Commission budget from potentially devastating cuts. The Commission's budget has grown from \$1,587,100 in 1979-81 to \$2,341,730 in 1985-87. With these increased funds the Commission has initiated new programs, including the development of community arts councils, performing arts touring, regionally based Artists-In-Education program, the Percent for Art program, and individual artist fellowships. Oregon was influential in developing the Partnership Test Program with the N.E.A., a program which has generated \$450,000 in new Federal and local government arts funds to match the State's contribution of \$150,000. New legislation creating the Tax Check-Off for the Arts was passed in 1982, a program which has now granted over \$366,000 for the development of much-needed arts facilities in the state.

Development program which resulted in the first publication of Where to Find the Oregon in Oregon guide, and now a series of Arts and Tourism workshops throughout the state which are helping communities use their artistic resources to develop the unique characteristics of their local areas. His dedication to pursuing trade opportunities with the Orient has helped open the door for such cultural exchange as the recent Ballet Oregon tour of Japan and Visual Arts Resource's touring exhibit from Japan, Tradition in Transition.

Through the Governor's Awards for the Arts, Gov. Atiyeh has honored outstanding artists and arts supporters. At his recommendation, Jefferson Performing Arts High School received the prestigious National Conference of

Governors Distinguished Service award. The Art in the Governor's Office program, managed cooperatively by the Governor's Office and OAC staff, Mrs. Atiyeh, and dedicated volunteers, has offered a most prestigious showcase for Oregon's finest visual artists and craftspeople. This Spring, the Governor's special interest in Native American art led to the first exhibit of contemporary and traditional

Too often we get caught up on "if only" thinking, dwelling on the funding limitations of the arts. Let us pause to celebrate the many accomplishments of this administration, and commend Governor Victor Atiyeh for his support of the arts in Oregon.

Dear Governor Atiyeh:

Thank you for eight years of selfless, dedicated service to the State of Oregon. Most notably I want to congratulate you for your foresight and leadership in the development of the international dimensions of Oregon's economy. Your efforts in this area are reflected through the significant growth and development in recent years of Oregon's international business community.

Though I never had the good fortune to travel with you, I followed you to the Far East on three different occasions. In all instances, the favorable impact and image that you created for Oregon and Oregonians made the accomplishment of my tasks possible. Unfortunately, few people in our State understand the protocol the State's Chief Executive is accorded in international commerce. You both understood and undertook this responsibility and the record clearly indicates your successes in the promotion of investment in Oregon, exporting from Oregon and Oregon as a state "Open For Business".

I know that many of your expectations of what might have been accomplished in your eight-year term were not realized. However, it is unconscionable that there are those in this State who fault you and your administration for not fulfilling your goals. There has never been a more critical eight-year period in the modern history of Oregon than during your two terms as Governor. The 1980 recession had a more dramatic impact on this state than most areas of the country. These external conditions, which were far beyond your control, required extremely difficult and many times unpopular decisions. But in all instances, you were economically and morally honest and acted in the best interest of Oregon. There were many occasions when it would have been much easier to follow a more politically expedient though uneconomically sound course of action. But this was not your style. At great personal cost, you elected to follow a course of action best characterized by the highest levels of statesmanship, leadership and management.



# Some Notes on the Hard Collar Era

a gentleman's a c coutrement that was an integral part of the beard and mustache era. I mean "hard" or detachable collar. (The detachable cuff



has long since become an antiquity.) Though it has been perhaps 20 years since I wore one, and inquiry at a local emporium brought the rather supercilious reply that hard collars had gone where the hosses went, I knew where to get the authentic lowdown. I looked up R. C. (Dutch) Brummer.

Mr. Brummer had just re-turned home after a session in hospital, to resume his usual life and customs which, for half a century, have included the wearing of a hard linen collar separate from shirt. "It is true," he said reflectively, "that there is no real future in the collar business.

"Though few stores stock them and even refuse to order half a dozen for an assured customer," he went on, "I know a couple of merchants who, being men of great good will, will stock them for men who do not consider themselves dressed-indeed, consider themselves half naked, without a good clean hard collar every day. They now cost 55 cents each. For decades they sold two for a quarter. Laundering? The last collars I had done at a laundry lars I had done at a laundry cost 18 cents apiece. The charge used to be two cents. Today the laundries don't want them at any price. My wife does them at home, beautifully."

Mr. Brummer said that reversable paper collars, not linen, made a comeback during World War II, due to their popularity in the Navy. Paper collars are not laundered, but thrown away.

thrown away.

The great authority on the history of hard collars was the late Samuel Hopkins Adams, who told me they were originated by the Rev. Ebenezer Brown, a Methodist minister of Troy, New York. Because of ill health he opened, in 1821, a small drygoods store; and happened to meet Mrs. Orlando Montague, wife of a Troy blacksmith. Her husband's collars naturally got soiled every day and were, in that time, a part of the shirts. To save so much washing, she cut off the collars and washed them sep-

Well, sir, this gave the Rev. Ebenezer Brown an idea. He induced several neighborhood women to make separate col-lars, and to wash and iron them as needed. He packed them in neat cardboard boxes, by sizes, and put them on the market. And lo, both the detachable Troy collar and the modern steam laundry came simultaneously into being.

The Rev. Mr. Brown wasn't done. With one George Jones, from Poultney, Vermont, he founded the firm of Brown & Co., and moved to New York

Co., and moved to New York City, where scores or works and girls were hired to make

at least endure, for another hundred years. Brown became well-to-do. As for George Jones, the "company," he lat-er teamed up with Henry J. Raymond to found The New York Times, of which for many years he was editor and publisher.

Time passed. The hard linen collar remained. Neither the paper article, nor the celluloid "washable," made a dent in its popularity. Then, on some unmarked and forgotten day, the collar started its return to being a part of the shirt. The eight-year record of your administration in the history of Oregon, in my opinion, will be one of contribution and progress towards Oregon being a greater state. May you and Dolores enjoy your changing roles as this year draws to a close.
