Dear Ms. Ness:

This letter is written to express our concern and extreme dissatisfaction concerning the lack of timely reimbursement to Access Oregon for services performed in accordance with our CDBG contract for Housing Services.

Our contract with Washington County Community Action Organization (WCCAO) states: "a monthly report of expenditures and services provided to Washington County residents is to be submitted by the 10th of each month." Typically, our report and request for reimbursement is mailed before the 10th of each month. The contract also states that "payment by Washington County Community Action Organization to the contractor will be made monthly upon receipt by Washington County Community Action Organization of a properly executed cost reimbursement request."

Billings and service reports were submitted July 6, 1990 for June services in the amount of \$1,286.43 and August 6, 1990 for July services in the amount of \$766.94. In another ten days, we will be submitting a billing for request of August expenses reimbursement.

Linda Jones, Access Oregon Business Manager, has called Washington County Community Action Organization on two occasions to inquire about the status of payments due Access Oregon. She was told the "new" 1990-91 contract money from the State was not yet available to Washington County Community Action Organization. This raises significant financial management concerns. Why are "old" 1989-90 CDBG grant funds not available to pay contract expenses for the June 1990 time period? If there has been a hold up of release of 1990-91 CDBG funds, why haven't we at least been given notification that our payments would be delayed?

We feel it is poor business practice for Washington County Community Action Organization to force Access Oregon as a CDBG Housing Service contractor to rely on our own line of credit to meet payroll and other contract expenses while we await reimbursement due to us. We provide the services to Washington County consumers in good faith per our

contract requirements and we submit service reports/reimbursement billings in a timely manner. In turn, we expect regular payments.

We await an immediate reply regarding this issue.
