# Salaries add up

## Survey lists highest-paid state workers

Last week Karen Sexson found an extra \$33 in her paycheck. Sexson, a clerk in the state Executive Department, said she probably will use the windfall to join the YMCA.

"Thirty dollars, it'll go quick," she said.

Like most of nearly 40,000 state agency employees, Sexson received a second pay raise granted by the 1985 Legislature to compensate for years of wage freezes. Last year most state workers got a 5-percent raise. This year most got 3 percent.

And, like most state workers, Sexson's pay raise means little more than some extra bread on the table.

For some of the highest-paid state employees, the raise is meatier. David Nicodemus' \$14,000-a-year raise is among the largest.

Nicodemus, the dean of faculty at Oregon State University, was paid almost \$56,000 last year. His salary this year is nearly \$70,000.

Nicodemus is 57th among 407 state workers ranked by salary in a Statesman-Journal survey of state employees earning more than \$52,000 a year.

The survey included all state agencies and commissions, all state judges and all higher education administrators. Teaching faculty members at the state's colleges were not included in the survey.

Higher education officials applaud Nicodemus' raise.

Davis Quenzer, higher education's chief budget officer and one of those to make the list, said the increases were long overdue.

Among 108 doctoral-granting universities in the country, Oregon State University ranks 97th, just ahead of the University of Oregon, in average pay for faculty and administration.

Quenzer said the ranking was an improvement from previous years, largely because of the \$40 million that lawmakers gave for improving salaries in higher education.

And higher education officials are aiming even higher. Within six years, Quenzer said, the agency hopes to rank 35th on the list. For that to happen, the pay increases will have to continue.

Despite the low ranking among their peers, higher education administrators occupy 44 of the top 50 spots in the state pay ranking.

As he has since the Statesman-Journal began its survey in 1979, Dr. Leonard Laster, the president of the Oregon Health Sciences University, tops the list.

Laster, who is paid \$104,160 a year, is among the 104 administrators at the state's eight colleges and universities to make the list.

The survey, which uses salaries as of July 1, found that:

- All 158 of the state's district, circuit and appellate judges made the list. In fact, more judges appeared on the list than any other single job title.

- About 40 women are scattered throughout the rankings. Nine are

among the top 100. The highest paid is Carol Lindeman, dean of nursing at the health sciences university. She is 16th on the list with a yearly salary of \$80,568.

- The athletic directors at the state's two major universities are paid more than Attorney General Dave Frohnmayer or members of the Oregon Supreme Court.

Lynn Snyder, athletic director at Oregon State University, is 83rd on the list with an annual state salary of \$65,004. Bill Bryne, at the University of Oregon, is right behind at \$64,633. Both men's state pay is augmented by thousands of dollars from booster groups.

- Although Gov. Vic Atiyeh ranks 39th on the list, he is well ahead of the highest-paid state agency director. Last year Atiyeh ranked 20th overall. Two years ago, before lawmakers gave him a pay raise, he was 67th.

The directors of five state agencies are paid a \$62,988 yearly salary, 94th on the list.

In comparison with Washington state pay scales, Oregon appears to be holding its own with elected officials and some higher education administrators.

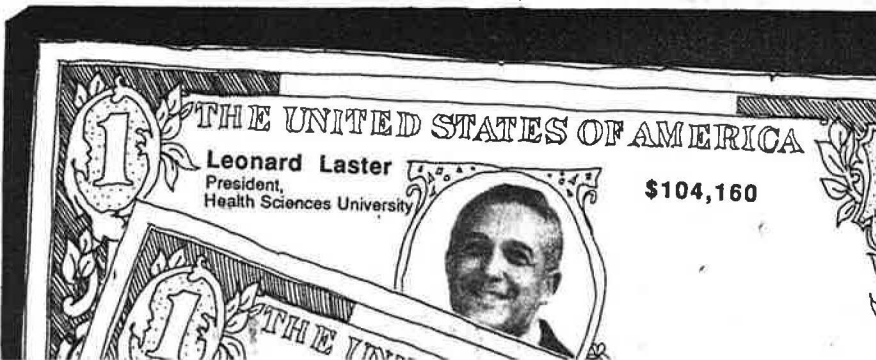
Currently, Washington Gov. Booth Gardner earns \$9,000 less than Atiyeh, or about what the top five state agency directors are paid. However, Gardner's salary will jump to \$74,900 in five months.

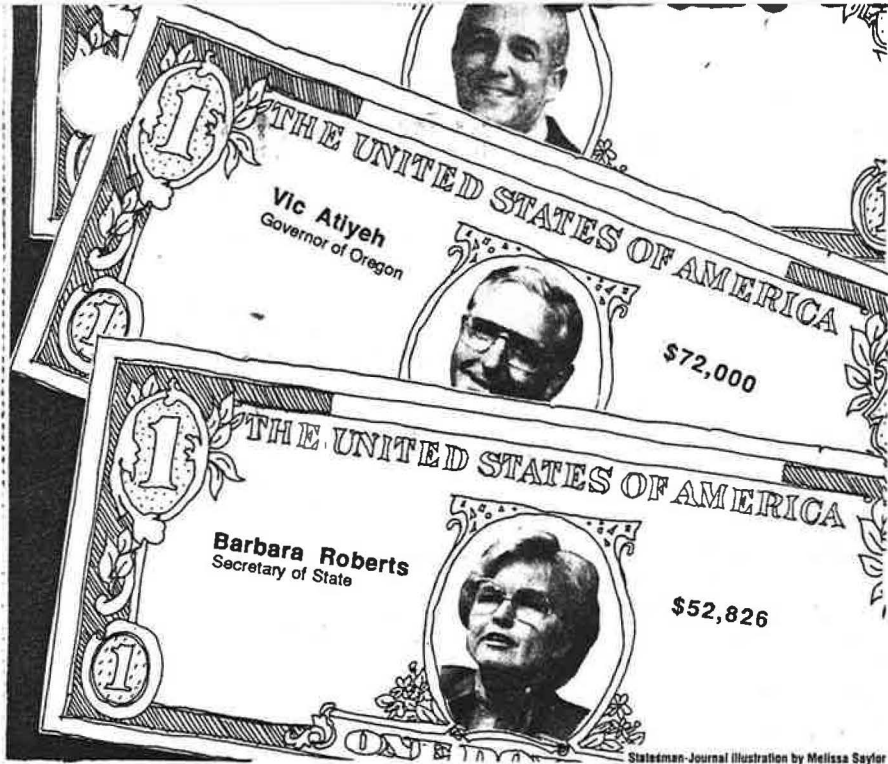
The highest-paid state employee in Washington is Robert Muilenberg, who heads the two hospitals associated with the University of Washington. He is paid \$105,000, slightly more than Laster at Oregon Health Sciences University.

# Marion pays the most

You live in the Mid-Willamette Valley and want a top-dollar job as a county official. Where should you look?

If you're considering a job in Marion County, look no farther. Compared with five nearby counties — Polk, Yamhill, Benton, Linn and Lincoln — Marion has the highest pay levels.

Marion County officials say that should come as no surprise.

"We would never compare ourselves to those counties," Ken Roudybush, Marion County's administrative officer, said. "The size of Marion County alone sets it apart from the others."

He said that when Marion County officials want to compare salaries, they turn to governments with which they have more in common: Clackamas and Washington counties to the north, the state of Oregon and the City of Salem locally, and sometimes Lane County to the south.

Roudybush said that in setting its salary levels, Marion County must consider the position and the responsibility involved.

"We need a salary schedule that will attract the caliber people we want to manage the county ... in the long run, a poor manager can cost a lot of money."

The executive director for the As-

sociation of Oregon Counties said that the task of comparing salaries by counties for supposedly similar jobs can be likened to the proverbial comparison of apples and oranges.

In most cases, Jerry Orrick said, elected officials perform similar functions. But for appointed positions, counties may organize departments as they see fit. Similar job titles in various counties may not mean that the employee has the same responsibilities.

If there's one thing the counties have in common, Orrick said, it may be that they are sensitive to the job market. "They want to set salaries that will attract employees of appropriate quality for the tasks to be done."

There is an exception, of course: lack of funds to pay desirable salaries. "When a county has limited resources, it's a problem," Orrick said.

Comparing salaries paid by neighboring counties was a task that Polk County began nearly a year ago.

To establish a basis for revamping salaries that lagged behind those of counterparts, the county's department of budget and finance surveyed five neighbor counties:

Marion, Linn, Benton, Yamhill and Lincoln.

Results showed that in one case, Marion County, there was no basis for comparison.

In the introduction to the survey, Ralph Hanley, Polk County's director of budget and finance, wrote that "... for whatever reasons Marion County is marching to the beat of a different drummer when it comes to salaries. Marion County salaries vary so greatly from those of other counties (surveyed) that they become useless even as guidelines."

Other counties, however, haven't used only each other for comparisons.

In Yamhill County, for example, where a new salary schedule was established in 1985, comparable jobs in the private sector also were considered.

John Krawczyk, director of administrative services, said that the Seattle firm of Norman D. Willis and Associates studied the county's management organization and the various responsibilities of the managers. It then looked at jobs in businesses located in communities of similar size.

"As much as anything, the board of commissioners were interested in the matter of pay equity," Krawczyk said. "The board wanted to be sure that a public employee was as fairly compensated as if he were working in the private sector."
