SUBJECT: Rajneeshpuram

Over the weekend of March 19 and 20, my wife and I were in Central Oregon visiting Rajneeshpuram. This was by prior invitation of Swami Prem Jayananda (formerly John Sheffner, who was active in New York and San Francisco international banking circles). He is President of the Rajneesh Investment Corporation, and husband of Sheela. He had given assurances that our visit would be treated simply as that of sightseers, that it would not be publicized, and that serious official business would not be discussed. However, I advised Jayananda my job is full-time, and in fairness he should be aware that whatever I saw or heard might be reported to my employer.

As I indicated during staff meeting on March 21, I believe there are two issues involved in evaluation of the Central Oregon situation. The first concerns application of landuse planning principles -- what is the group actually doing as it affects pre-resident individuals of the area, and the environment? Second, what is the character of the group?

Rajneeshpuram the City.

I am not an expert in land-use planning or relevant laws, so far as procedural requirements are concerned. My ignorance allows me to stand back and assume (perhaps naively, but not facetiously) that the purpose of land-use planning is to facilitate orderly development of land in such a way as to achieve optimal use of its natural resources and esthetic characteristics, all looking toward a legacy for coming generations.

Prior to two years ago, the Big Muddy Ranch had been used for the grazing of cattle and sheep. A succession of owners had found it economically unprofitable for such operations -whether through their lack of expertise, or other conditions, I cannot say; but it was overgrazed, and was entering a phase of destructive erosion. Prior owners apparently were happy to dump it at a price that enabled them to get away with little more than they had put into it.

Access to Rajneeshpuram is not easy. One first drives from US 97 more than 10 miles on a narrow, winding road to Antelope; then another 12 miles on a well-maintained but unpaved, narrow and winding road to the community. The countryside along the way is rocky, supporting sagebrush and a few junipers.

Grass is sparse. Crossing into Rajneesh property, things looked much the same except there is a green carpet of grass coming up, even beginning to smooth out the criss-crossing cattle paths running along the slopes. The transition is striking (Followers of the Bhagwan do not eat meat. They have some dairy cattle but are not using the vast bulk of their lands for grazing at this time.)

Coming down into the valley of the Big Muddy, one sees an impressive array of structures spaced for several miles along the road. I took numerous pictures of these individual structures, but none will capture the panorama of intensive development. Nearly all the residences are smaller "Aframes" set up along the hillsides -- the bottomland is mostly under cultivation. Expensive construction equipment is much in evidence. There are machine shops, warehouses, a furniture factory, a landingstrip with two planes ("Air Rajneesh"), a large cafeteria, a community hall, and several office structures. Toward the east is an enormous building used to house the festival last summer, which is intended to be turned into a greenhouse after the festival coming up next July. There are about a dozen other, smaller greenhouses smaller only by comparison with the big one. Further to the east there is a large dairy barn, and additional facilities for raising poultry (the Bhagwan allows his followers to eat eggs and consume milk).

In the area of the original ranch house, there are trailers set up and used as a temporary City Hall, Post Office, Planning Department, Geological Analysis Laboratory, auto repair shops, etc. Jayananda and Sheela live in a luxurious residence nearby made up of several large trailers. The Bhagwan himself lives in a similar facility on a hillside nearby -- the area around his residence is magnificently landscaped and is staffed, in addition to several gardeners, by a flock of peacocks.

We were shown through some of the business offices. As you would expect, the men and women working there have the very latest in computerized office equipment. Knowing a little about such things, I have no trouble accepting the assertion that 10 people using this equipment can do the same amount of "paper work" for which 100 people are required in more conventional offices. Although we were not told so specifically, I suspect this is the headquarters of their world organization — the repository for membership information, financial transactions, publication distribution, etc.

We visited the clinic, which is run by Puja. She is a licensed nurse-practitioner. (In Oregon, this means she can perform some of the functions of a physician -- within limits, she can diagnose illnesses and write prescriptions.) Three Oregon-licensed physicians, one licensed chiropractor and two registered

accupuncturists also reside in the community. They have regular office hours in the clinic, and are available on-call around the clock. Persons having more serious illnesses or injuries requiring hospitalization are flown to Redmond -- the clinic has no in-patient beds. Judy, who is familiar with such matters, says the equipment is the latest and best, and it is her opinion that any Oregon hospital would be anxious to hire someone of Puja's training and skill.

In the greenhouses, seedlings are raised for transplantation outdoors (or for consumption as sprouts). Each greenhouse has a double-thickness of plastic, and its own heating system.

The dairy barn is incredibly clean, and we did not see a single fly. I am not qualified to assess agricultural equipment, but the milking machinery and facilities for pasteurization were impressive. Each cow is individually tagged, and appropriate mixtures of feed are delivered to it. The chicken yard also is clean, and there is a wide variety of fowl used for egg-production and experimental breeding. (The flocks include a pair of emus, a huge bird like an ostrich. I thought they were extinct, but obviously they are not!)

The first sheep had been delivered a few days before. They are to be used for wool production at some time in the future. There was talk of spinning the wool and weaving on the ranch for boutique sale.

The community's sewerage system is under construction. They have one lagoon in use, and another, larger lagoon in progress. The Health Division and DEQ have approved all the work, which was designed by resident engineers and constructed by resident labor. (There are members of the community who are registered professional engineers.)

The city is patrolled by a "peace force" of several officers. Two are graduates of the Police Academy at Monmouth, and three more are scheduled to attend the next course. The two whom we met -- one male, the other female -- wore badges and were armed, and looked like ordinary policemen except for the (red) color of their uniforms. They discussed their duties in professional terms. They claim their work consists mostly of giving directions to motorists passing through the property on the county road, and encouraging hostile visitors to move on. They claim they have no occasion to provide services to residents of the community (although Jayananda, at another time and place that day, remarked that the peace officers sometimes intervene to calm domestic quarrels).

All things considered, I would say Rajneeshpuram is a clean, orderly, prosperous community. In physical terms, it is oriented primarily toward rural and agricultural pursuits. Obviously,

a lot of other business goes on which could just as well be transacted in downtown Portland. This may violate strict application of land-use principles, but in my opinion it is unrealistic to argue these business activities are harming the quality of the area. A poet might say they are "making the desert bloom." One must recognize that many can argue persuasively the desert should not be made to bloom -- any more than the wild coast of Oregon should be lined with resorts. The thought that comes to my mind right now, is that anybody has to take a great deal of time and go to considerable trouble, journeying far out in the boondocks, to be offended by activities at Rajneeshpuram.

Rajneeshpuram the Community.

Having been favorably impressed by developmental and conservation activities on the old Big Muddy property, I came away with a distinctly more negative impressions about the social dynamics of the group. I had told Jayananda that Judy and I are not philosophical people, so neither he nor anyone else tried to proselytize us. I cannot claim to have any deep understanding of what the Bhagwan's philosophy is, or how it is perceived by his followers (if, in fact, all perceive it the say way).

In this connection, Jayananda and Sheela told us the followers of the Bhagwan all think with one mind, and strive in unison to achieve a more complete understanding of their Master's enlightenment. We were assured there were not disciplinary problems involving members of the group. Nevertheless, on page 5 of the Rajneesh Foundation International Newsletter dated March 15, 1983, there is a "message to all "sannyasins" (copy attached) indicating the existence of factionalism -- warning faithful followers of the Bhagwan not to associate with "a few people, who had been hanging around without growing at all," and who are referred to in the notice as "ghosts."

Hardly for a moment during our visit were we without the escort of some senior member of the group. If one was called away, another suddenly appeared as if from nowhere. To the best of my recollection, we were alone on an individual basis only with Jayananda; Sheela; Swami Krishma Deva, the Mayor of Rajneeshpuram; Puja, the nurse-practioner; and a woman whose name I forget, who is Mayor of Antelope. There was no opportunity to converse with any of the hundreds of other residents unless at least one of these senior members was within earshot.

Although followers of the Bhagwan describe themselves as living "communally," it became quickly apparent that their life-style is not according to Marxist traditions. Marx taught that in an ideal community each will give according to his or her abilities, and each will receive according to his or her needs.

The result, he declared, will be disappearance of all social classes. There are distinct social classes in Rajneeshpuram.

At the top of the heap is the Bhagwan himself. (In their publications, his followers capitalize the pronoun and would write, "The Bhagwan Himself.") His residence, as described earlier in this memorandum, is luxurious and includes such amenities as a heated, indoor swimming pool and a completely equipped medical clinic with X-ray. Everyone has heard about his automobiles. He goes for daily rides, and is adored by people lining the roads. Nevertheless, he remains a shadowy figure -- having contact with the group only through Sheela.

We were told the Bhagwan does not deign to concern himself with business matters involving Rajneeshpuram, but thinks solely about spiritual matters. It is claimed that he stopped speaking publicly or publishing about two or three years ago, and no one knows whether he will become communicative again. He still communicates on some matters, however. As we were being driven around the city by Jayananda and Sheela, Sheela was contacted on their radio. (Naturally, the group has an excellent communications system -- I recall Major Watson telling me last year that their radios are more sophisticated than those of the State Police.) At any rate, Sheela was summoned to meet the Bhagwan as he returned from his daily drive. Jayananda nearly drove the car off the road in his haste to be there, and Sheela literally leaped out of the car to run over and speak with the Bhagwan. We learned later, in a tangential manner, that the Bhagwan had changed his mind about which car he wanted to purchase next.

We were told the Bhagwan's health forced him to leave India, and he came to Central Oregon so that he could be away from pollution and consume more natural foods. Based on what they said, and numerous subjective impressions including his lapse into silence, Judy has hypothesized that the Bhagwan may have "slipped a cog" -- and that his isolation and silence is encouraged by his senior followers to preserve his image as a Great Master. On the other hand, Bob Davis met with the Bhagwan a few months ago when preparing to terminate his employment. Bob says the Bhagwan is one of the best-read and most articulate individuals he ever met, although quite naive about wordly matters going on around him.

Sheela appears to be the conduit for spiritual leadership of the group. She conveys to others whatever messages the Bhagwan cares to utter. She claims to be of East Indian birth -- her speech is that of a person who has learned all the rules of English grammar well, but thinks in some other language and has to translate when speaking. It is obvious she enjoys luxurious living. Judy, who is a good judge of expensive

household items as well as expensive medical equipment, says the table settings, furniture and other trappings in Sheela's residence are top quality. There were three or four people preparing the food and serving the table when we ate. They were not exactly servile, but their attentiveness was almost embarrassing. Although meat was not in evidence, the food otherwise was of gourmet qualith and the wine was first-rate. Shoes and smoking are not allowed indoors, but there is a carpeted porch immediately adjacent, provided with ashtrays for barefoot smokers. Others sharing the table included a gentleman whose name I forget (East Indian names do not stick easily), now vice-president of Rajneesh Investment Corporation and concerned with property acquisition and management; the Mayor of Antelope; a Soviet emigre who manages their data information and computer systems; a German who is in charge of their communications network; Swami Krishna Deva ("K.D."), Mayor of Rajneeshpuram; and Puja, the nurse-practitioner.

The table conversation went on pretty much as if Judy and I were not present, and involved such matters as the splicing of a telephone cable just inside the city limits, whether there should be a state lottery in Oregon, etc. It was the same sort of urbane and sophisticated table conversation one might hear at the Arlington Club, except that women were permitted to participate. Sheela sat at the head of the table, and clearly was the subject of special deference. Most of the time she was inclined to let the conversation wander from one subject to another, with only an occasional comment. Once or twice she apparently grew bored and brought up something else, and whatever was under discussion instantly was dropped and the others chimed in on the subject addressed by her.

Jayananda was identified earlier in this memoranda. He and Sheela were married two years ago. From other sources I have heard he is the financial expert of the community, and is known to be a frequent visitor to Zurich. He embraced the Bhagwan's teachings about six years ago. We had the impression that while he is adept at restating the Bhagwan's general philosophies, he is not much into spiritual matters and occupies himself as a vice president for operations.

Jayananda and Sheela showed us their office/bedroom. The room had one of the omnipresent portraits of the Bhagwan on its wall, but otherwise there was no sign of religious or philosophical materials. His desk had a copy of The New York Times, Wall Street Journal, Barron's, and a couple of foreign-language journals. Behind his desk, of course, was a computer terminal -- I would be fascinated to know what informational resources he can access through it. Sheela claims to prefer working on the floor, and part of the carpet was occupied by piles of pamphlets, proof-galleys, etc.

Within their residence were about two dozen other individuals -some of them cooks and servers, but the majority involved
in administrative activities which were not explained to us.
Telephones were everywhere, and there was a two-way radio
just off the living room.

At some point during the early stages of our visit, I had expressed an interest in the geological formations of the valley. (I started college as a geology major prior to seduction by the legal profession, and for two decades Oregon geology has been a hobby. I suppose I can claim to be a well-informed layman on the subject.) The city geologist, Ritan, suddenly appeared out of nowhere. He is a professional geologist who joined the movement in Australia. For months he has been conducting exploratory drilling as part of a survey of the ranch's water resources, and claims to have found vast and unsuspected aquifers. He says the successful wells have been capped for future use, all in accordance with state law (I have no reason to doubt this is accurate). In his spare time, Ritan has been collecting fossils, and some of his specimens are impressive. He speaks with authority about Miocene fauna and Clarno strata. However, he apparently is an individual who, for some reason or other, is not authorized to speak privately with outsiders. Our attention was distracted to some other subject, and a few moments later Ritan and his specimens had disappeared as completely as if they had never been there!

Then, and on some other occasions, Judy and I had the creepy feeling that our hosts were sorcerors who conjured the presence of interesting people to entertain us for a period, then whisked them away as soon as our heads were turned momentarily.

Sheela and Jayananda conducted us on a tour of the ranch -in a Mercedes-Benz. I have described most of what we saw earlier in this memorandum. Each work program appears to be under the leadership of a "coordinator", who oversees a varying number of individuals depending on the activity. Jayananda seemed intimately familiar with each operation and the coordinators; Sheela appeared to be sight-seeing as much as we -- her only expressed concern was that everything be "tidy." At one place -- the greenhouses, I believe -- the coordinator was not present when we arrived, and I thought I detected a bit of irritation in Jayananda's voice when he insisted that he be sought. The coordinator appeared shortly thereafter, and conducted us on the tour. Even then, we did not have an opportunity to speak privately with him, much less the numerous workers in the facility. As everywhere they appeared "happy, happy, happy." When we asked questions -always in the presence of Jayananda or Sheela -- we did not detect fear on the part of those with whom we spoke but I sensed a degree of nervousness on many occasions.

All the residents, except for the senior members, eat communally in a large cafeteria and dining hall. We toured the kitchen, which is the cleanest I ever saw. (As a former Administrator of the Health Division, I would give it a double-A rating, if such existed.) Because of their custom of eating in common, there is no need for kitchen and dining facilities in the individual residences.

We were taken by the school. As you know, State Board of Education standards for private schools are "loose" at best. There were perhaps two dozen children of kindergarten or primary age. The school house, like everything else on the ranch, is immaculately clean. There were no classes in progress at the time. We were told middle-and high-schoolers have jobs part of the day, and attend school the rest. A question about graduation requirements or equivalencies evoked an answer that glided off into incomprehensibility. I believe one can say objectively and impartially that formal education, in the conventional sense, does not have a high priority among followers of the Bhagwan — even though the ones with whom we spoke obviously were well-educated.

This brings up another point, which did not jell in our minds until we had left. Although the overwhelming majority of the residents of Rajneeshpuram are young men and women under 40, there is a virtual absence of small children — the youngest we saw was a toddler, perhaps 18 months of age. Judy remarked that among all the hundreds of young women around and about, she did not observe a single one who appeared pregnant. Though it is not uncommon to see couples embracing and being affectionate almost anywhere within the community, and the Bhagwan's teachings do not place a premium on chastity, children do not seem to be a part of the plan.

The end of the tour came with a visit to the newly opened "disco." The facility has a beer-and-wine license from OLCC, and a full-service application is pending. One of the peace officers was stationed at the door. It could have been a disco anywhere else, except the music was not quite so loud and everybody was dressed in red. A rock band performed what I presume to be standard works (I am not a rock fan myself), but ended with a composition of their own -- the dancers gyrate to a monotonous repetition of the lyrics, "Yes, Bhagwan, Yes! Yes, Bhagwan, Yes! Yes, Bhagwan, Yes!", and so on. We were told that persons attending the disco are expected to limit themselves to two beers or glasses of wine -- that occasionally some lose count, but Rajneesh taxis stand by to be summoned by the management and drive the confused customer back to his or her residence, even assisting them to bed.

There are shops in the main part of the city where outsiders can buy clothing, souvenirs, books, etc. -- Visa and Mastercharge accepted. Prices are comparable to those in tourist shops elsewhere. For residents, so far as food, clothing and other necessities are concerned, there is no medium of exchange (there is no cash register in the cafeteria, for example). We asked Jayananda how they might deal with a situation where a resident is perceived not to be putting out his or her fair share of work, but continues to consume food and expect other perquisites of membership. Jayananda said attempts are made to counsel these individuals, and attempts are made to assign them to jobs more suited to their inclinations and talents -unless they are disabled because of age or illness, in which case the community will assume responsibility. I posed the problem of an individual who gains residency through deceit and turns out to be nothing more than a freeloader. Jayananda was somewhat rambling in his answer -- alleging this simply didn't happen, that in such a case the individual would not feel at home and would be "spun out" of the community. respect to this and other occasions, sometimes our specific questions received non-specific responses. Judy says she has heard the same thing from me sometimes when I am asked a question on a political issue which I prefer not to answer. She says my response is articulate and coherent, and usually seems to address the proponent of the question logically and to his satisfaction. Only later, she says, does she realize I really have said nothing of substance, and the questioner has received no useful information whatever. Come to think of it, I suppose I do that on occasion -- and I believe the same technique was frequently used by our hosts at Rajneeshpuram.)

As I said at staff on Monday, it is not my concern if people want to donate their labor to some cause which appeals to Though I do not feel drawn to the monastic way of life, I do not find fault with the Benedictine monks at Mt. Angel; and though I am not attracted to the Bhagwan's philosophy, it is equally hard to find fault with those who are. Some of them have been on other "trips" -- we heard references to So-and-so, who had "been through scientology"; and Thusand-such, who kahad "tried EST" or other disciplines. Perhaps these remarks were intended to have us conclude those other schools and practices certainly must lack merit, because such intelligent individuals had tried them and found them wanting. We believe a different conclusion can be drawn -- the individuals are of a type one encounters from time to time among highly educated people, who constantly are searching for the meaning of themselves and the purpose of their existence, and who regularly attend encounter groups, retreats, etc. seeking to "find themselves." On its face, the Rajneeshpuram society


offers escape from the pressures of the world they find troublesome; an escape from intellectual doubts, through acceptance of the Bhagwan's teachings (he still lives and has a spokesperson, so there has not yet been an opportunity for emergence of sects, heresies, schisms, etc.); security approaching that of the womb (there is always someone around to assign tasks, make decisions, take care of one's daily needs); and continued enjoyment of comforts and luxuries (the A-frame cabins are electrically heated, the dining hall is clean and nourishing food is served, and workers have the best of tools, whether earth-movers or word-processers.

In chatting about his break with the group, Bob Davis told me he sensed -- without being able to define -- an undercurrent of potentially suicidal thought among those with whom he spoke. We cannot say we sensed this in any degree among the senior members -- all of whom appear to be pragmatic, rational individuals (they do not sing and leap in the air when the Bhagwan drives by). I am not so sure what might happen among the hundreds of workers, however, if the Bhagwan and the senior members took a notion to harm themselves.

Additionally, if some confrontation with another group arose, I am confident the Bhagwan's followers would not provoke violence --but turning the other cheek is not part of the Bhagwan's teachings.

The dynamics of this group are complex, and I am not certain anyone can understand them fully without being a member of the group -- and a member of the senior group, at that. My general conclusion is the group consists of hundreds of young idealists who have taken up the movement as a means of escaping troubled lives -- and who can say they are not better off for it? They are led by a very small group of brilliant, highly competent and apparently stable individuals who profess obedience to the Bhagwan's teachings, but do not seem very excited about philosophy as compared with their preoccupation over running the movement and building a city. Your guess as to the nature of their individual and collective motives is as good as anybody's, in my opinion.

Earlier, I referred to the "happy, happy, happy" demeanor of everyone we saw. When we left the ranch and began to exchange impressions, we agreed this prevailing attitude was becoming depressing after only a few hours of exposure. We agreed it lacked spontaneity — it was as if there was a general agreement to chop off half the range of normal human emotions. Occasional spells of irritation, grouchiness and being down-in-the-dumps makes all the more meaningful those occasions when we really are prompted to be joyous.



RAJNEESH

July 1981 the Chidvillas Rajneesh Meditation Center, incorporated in New Jersey in 1977 as a religious tax exempt organization, purchased the Big Muddy Ranch in Central Oregon for reported 6-7 million dollars. The ranch, 64,229 acres of which 50,000 acres lies in Jefferson County and 14,229 in Wasco County, was immediately occupied by about 50 members of the organization and renamed Rajneeshpuram. An additional 17,000 acres of BLM is under lease.

Shortly thereafter the organization purchased property and businesses in the small nearby city of Antelope, population 40. Residents of Antelope attempted in April 1982 to dis-incorporate the city but failed when the Rajneesh met voter requirements with sufficient numbers to retain the city.

July 1982 and each successive July after Rajneeshpuram has held a world-wide Festival at the ranch. The 1982 Festival attracted approximately 5,000 persons and grossed a reported 4 million dollars; the 1984 Festival attracted approximately 15,000 people and grossed an estimated 12 million dollars.

Rajneeshpuram has an established Peace Force consisting of 10 BPST certified officers and in July 1984 reported 39 reserves.

The Rajneesh Council at Antelope has contracted with Rajneeshpuram for police services to provide 24-hour coverage. Antelope's population at present is approximately 80 Rajneesh and 13 non-Rajneesh. Rajneesh has expanded their business holdings with a hotel in Portland, which was bombed in July 1983, and a Portland nightclub and bakery.

Early September 1984 the Rajneesh announced a new program of importing "Street People" from several major cities, primarily the east coast, to the ranch to train them in a productive trade. Ground construction is underway in Antelope, now renamed Rajneesh, and a modular "man camp" has been purchased for erection. Reportedly approximately 1,400 "street people" will be housed in Antelope when facilities are completed.

Latest estimate indicates about 1,500 Rajneesh and 1,000 street people reside at Rajneeshpuram.

Worldwide Rajneesh population is reported at 400,000.

MAN CAMP UPDATE

A modular city used by a mining camp in Challis, Idaho was purchased by the Rajneesh at a reported cost of \$5.5 million. The modulars were transported to Ontario and held there until the City of Rajneesh (Antelope) was ready to receive. Ten days ago all modular units had been moved out of Ontario, presumably enroute to Rajneesh. A flyover by the Military in the last three days determined these modulars are now in place at the city of Rajneesh.

Originally Rajneesh had projected a completion date of their man camp by November 1. Completion was stalled due to a question of sewage disposal. Originally the Rajneesh planned to truck the sewage to a local sewage plant, presumably their own. This was denied and now they have in place a total and complete septic tank service.

The main camp will house primarily street people who are currently housed on the ranch in tents and A-frames. The main center for street people on the ranch is currently the Walt Whitman Park. However, there are three other locations on the ranch in addition to the Whitman area.

Once housed in the main camp at the city of Rajneesh, street people will be bused back and forth to the ranch for work or, as they call it, worship.

The main camp is capable of housing 6-700 without double bunking. With double bunking the capacity is increased to 1,200-1,400.

The Rajneesh reported Friday, November 1, to the Oregon State Police that they had remaining on the ranch 2,350 street people. This figure reported by the ranch is close to the prediction OSP has also made.

Military reported today, November 5, that they had received information that the man camp would not be utilized until the cafeteria is finished. Approximate date of completion given was November 15.

Concerns for security increase once the man camp becomes inhabited. Security concerns center around activities that may be provoked by outside forces.

The Building Codes Division treats Rajneeshpuram the same as any other city or county under its jurisdiction.

There is, however, some conditions in their case that differ from other cities. Without reciting all the litigation involved, I will point out one that affects the issuance of electical permits within the alleged city limits.

There is a court order that precludes the City of Rajneeshpuram from issuing "permits authorizing development, construction, installation or establishment of structure, facilities or urban uses within the City..."

The injunction was clarified on June 15, 1984 to permit the "City" to issue certain permits (See Exhibit A), with the condition the "City" gives Wasco County Planning Department 48 hours notice. If the County objected to the issuance of the permits, the matter must go to Court for a decision.

Although the Building Codes Division was not included in the court order, we have tried to abide by the spirit of the order and contact Wasco County Planning Department prior to issuing electrical permits, to be assured they have approved the construction proposed by the "City".

There have been some contested cases that caused us to delay the issuance of electical permits until the matter was settled (See Exhibit B). This procedure is with the advice of the Attorney General's Office. It is quite often one attorney feels an opposing attorney gives their client bad legal advice.

A second issue which differs from that above is the installation of a number of prefabricated buildings that have been moved into the "City of Rajneesh" (Antelope).

Before issuing electrical permits for the buildings to be connected for electrical service, it is necessary for us to verify the electrical system is safe and conforms to the code. The Chief Electrical Inspector for the Building Codes Division personally inspected some of the buildings. He agreed with the Rajneesh Neo-Sannyas International Commune that if they would supply him with inspection records from the state (Idaho) where the buildings were built, he would not require the electrical systems within the walls to be exposed for inspection. While he was making his inspection and agreement with Ma Anand Venu, they were recording every word. However, they did not send him the documents he had requested and he informed them

by letter (See Exhibit C) he would not approve the buildings for electrical service until he received the documents he requested. He was accused of using "delaying tactics", which I assure you is not true.

The problem with the prefabricated buildings has not been discussed with the Attorney General's Office, as this has nothing to do with the court orders and is our standard procedure.

We issue electrical permits in the standard manner statewide except for that portion of the "City of Rajneeshpuram" which court orders affect.

Dear Sw. Krishna Deva:

I have discussed our telephone conversations of September 19, 1984, with County Council, Will Carey, and this letter is a follow-up to insure that there are no misinterpretations of what was discussed or what County policies currently are. As I explained, all permits issued by Sw. Sandesh pursuant to the Circuit Court Order, dated June 18, 1984, relating to the relocating and placement of non-residential modular facilities are temporary permits only, as the above Order provides, and as temporary uses could be required to be removed in the future.

It is further my understanding from our conversation that you agreed to stipulate to an Order which would allow County officials to conduct inspections at Rajneeshpuram during normal working hours, Monday through Friday, on an unannounced basis as long as such officials checked with City Hall and announced the purpose of the intended inspection and what locations were to be inspected. Based upon this agreement by you to stipulate, I then would review the two pending permits that were in my office and this was subsequently accomplished.

Since that time I have received two more permit requests, dated September 21, 1984, and received by me at 1:10 P.M. Legal council to the County advises that a stipulation is being prepared for an Order to be signed by the Circuit Court Judge which will effectuate our agreement. As soon as the stipulated Order is signed, I will process the two pending permit applications.

You are hereby advised that until such Order is signed by the Court, the County must object to the issuance of the pending permits and will not consider approving any further permits. The signed Order should eliminate any future problems concerning inspections by County officials and, hopefully, will alleviate the harassment of County officials as evidenced in the past.

I am one of the coordinators of Chuang Tzu Temple which is the part of Rajneesh Neo-Sannyas International Commune ("Commune") Responsible for building. Under an agreement with Rajneesh Investment Corporation, the Commune plans to add extensions to two existing structures.

The specifications for each extension are for all practical purposes the same. One extension is to be built onto Magdalena 7, a mobile home, the other onto an A-frame quadraplex situated in Jesus Grove. Both extensions are to be constructed so as to be removable if needed. The total area for each extension is less than 500 square feet.

Each extension consists of a wooden framed structure attached to the existing building by a short passageway.

The extra addition including the passageway is on a removable concrete block foundation similar to other mobile home blocking.

Each addition provides for two bedrooms (approximately 12' x 12') with individual bathrooms. Access to each bathroom is from the passageway which connects to the main building.

Only minimal electrical plumbing and sewer connections are required and will be connected to the lines serving the

existing structures. A separate gas heating system is to be installed in each extension.

On June 18, 1984 I accompanied the Rajneeshpuram City Attorney, Ma Prem Sangeet, to Hood River
in order to seek clarification of the preliminary injunction in CC 83-202. I helped Ma Prem Sangeet and Wil
Carey, attorney for Wasco County, develop language to
present to Judge Jelderks on this issue.

We met in the jury room of the Hood River

County Courthouse. We discussed the specific language
of section 1-c at length before presenting it to Judge

Jelderks. We all agreed that this language would allow
additions of bedrooms, bathrooms and the like. Mr. Carey

On June 18, 1984 I met with Wilford Carey, attorney for Wasco County, to discuss a stipulation for clarification of the preliminary injunction in McGreer v. Rajneeshpuram, CC 83-202.

We agreed that additions of 500 square feet or less to existing structures would include such things as decks, porches, bathrooms and bedrooms. We agreed that the County would object if it felt too many additions were being approved by the City.

In discussion with Judge Jelderks I stated that the provision for 500 square foot additions would cover small additions such as decks or porches. That language was added to the order. I did not understand that to change in any way the agreement I had with Mr. Carey, and Mr. Carey did not indicate to me that he believed our agreement to be changed.

I believe the permits which the City has proposed to approve are within the understanding I had with Mr. Carey and are permissible under the court's order of clarification.

RAJNEESHPURAM - ANTELOPE

September 6, 1984

Major Lamkin advises that Ranjeesh presently breaking ground in Antelope for barracks type dormitory. Also have information that a "man camp" with approximately 1500 capacity will be moved into Antelope. Complaint was made to our Bend office from one of the 8-9 non-Rajneesh in Antelope about excessive dust from the construction. Ranjeesh advise they will water the area.

September 7, 1984, 10:00 a.m.

Bob Oliver advises Bill Bellamy called very concerned about people moving into Rajneeshpuram (street people). Major Lamkin will call Bellamy to reassure him.

2:00 p.m.

Major Lamkin advises he met with Bill Bellamy, District Attorney Mike Sullivan and Jefferson County Judge Reed. Explained our role, emergency plan, etc. and they seem satisfied. Bellamy thought that we should establish an outpost at Antelope and bring in the National Guard. Major Lamkin will contact and brief Senator Jernstadt.

This weekend fom Lamb, former policeman of the U. S. Department of Justice, and a mediator would be in Antelope and/or Rajneesh-puram.

Reportedly 30 busloads of "street people", primarily from New York, Florida and California will be brought to the ranch (22-28 persons in each bus). Transportation provided by Rajneesh. To date 4 loads have arrived, predominately black males 25-40 of age. 13 left last night, transportation paid by Rajneesh. Madras area residents are upset, concerned that these people will come into town and cause problems. Sheela advises there are 400 in now.

Information that Antelope will establish their own Police Department and not contract with Rajneesh.

Rajneesh people recently visited an abandoned mine near Challis, Idaho and showed interest in purchase of a "man camp" capable of housing 6700 persons. They have also made inquiry of Highway Department at The Dalles relative oversize permits to transport the camp.

Major Lamkin and Mike Sullivan scheduled to meet with Sheela on Tuesday, September II.

September 8, 1984

Major Lamkin advises that Rajneesh moved 7 used modular units into Antelope. May have come from the ranch. Only 4 "street people" came in and I black left last night.

September 9, 1984

Major Lamkin advises one busload of "street people" arrived Saturday evening. Water is now being shut off in Antelope from 10:00 a.m.-6:00 p.m. daily as a form of rationing.

September 10, 1984

Major Lamkin advises 2 members of the Wasco County Planning Committee and I deputy sheriff are en route to Antelope.

11:30 a.m.

Major Lamkin advises Joanne Boitz, Albany, 928-4087, called requesting State Police at the voting precinct at The Dalles for protection of voters and also protection and escort to and from the polls.

Our reason for not complying with the request - She stated she has also requested military protection from Ft. Lewis, Washington. She is trying to interest non-Rajneesh to take up temporary residence in Wasco County to vote against the Rajneesh vote.

2:45 p.m.

Captain Noland advises the 2 Wasco County Planning/Building Inspectors and I deputy sheriff were ordered out of Rajneesh-puram and told search warrant was necessary. A Highway Department employee was also told to leave when he stepped on private property at Antelope while checking drainage ditches.

Water issue clarified is turned off from 10:00 p.m.-6:00 a.m. daily, which is normal for this time of year.

First modular unit was observed today, south from Arlington on Highway 19 to Clarno. '30 more reported coming today. This may be the "man camp" now reported to provide for 600-800 persons.

September 11, 1984

On September II, one County Commissioner inspected the new building site at Antelope but obtained very little information.

Major Lamkin, Captain Noland, Lt. Thiess, District Attorney Sullivan and Sheriff Perkins visited Rajneeshpuram. The "street people" is apparently a Rajneesh International grant program with the purpose of training them for a trde and not for the purpose of membership. They have about 400 now and expect a total of 900-1000. Another program allows people to pay \$250 a month for room and board and take advantage of the training. Some appear to be drug abusers and are now in withdrawal state.

Rajneesh people denied the purpose was to obtain voting power. The Antelope building site was reportedly purchased from Keith Mobely, former Antelope City Attorney, and the local non-Rajneesh are now upset with him.

The militant projection is more pronounced at Rajneeshpuram They had lunch with Sheela who told them they are advertising for an Antelope Chief of Police. The size and budget of the Police Department could not be obtained.

At Antelope the presence of armed security is much more in evidence. They are armed with sidearms and have carbines in the vehicles, along with binoculars and radio equipment.

6-8 of the modular units are now at Antelope, parked, with about 30 more due.

So far about 30 street people have left. There was a fight about two nights ago between two blacks who were subsequently transported to Portland and put on a bus. One female reportedly with mental problems.

September 12, 1984

Request by District Attorney Smith for two members to go to Portland and interview a femal who claimed she was handcuffed for 8 hours and then evicted from Rajneeshpuram. Major Lamkin was to arrange for Portland investigator to interview if needed. Major Lamkin met with Rep. Fawbush and Senator Jernstadt, along with Federal Mediator John Mathis. Senator was understanding but Fawbush more demanding. Wanted to know why we didn't go in and take over Antelope law enforcement. Politicians concerned about the voting bloc.

We have at least I patrol in Antelope daily and more if available.

SEPTEMBER 13, 1984

One incident at Antelope involved a subject with apparent memtan problem from Terribonne (non-Rajneesh) was in possession of Hashish, investigation continuing, Two patrols in the area. Antelope population still about the same 8-12 non-Rajneesh and 90-100 Rajneesh.

Evening met with Gerry Thompson and Bob Oliver along with Bill Gary, A.G., and John Mathis.

Mathis explained his role as a Community Relation Service. They assess the chance of violence and if it should occur the statewide reaction.

He views the Antelope situation with two concerns: Political and Violence.

Political:

Rajneesh are more aggressive because they want recognition by the state and local Government. They perceive that the Governor and Attorney General have not sanctioned their existence. They currently have the capability to sustain themselves. Workdwide there are about 400,000 followers of the Bhagwan.

Sheela advises that she is prepared to sacrifice Rajneesh lives to attain their goal. Mathis clarified that he strongly believes that the Rajneesh will not precipitate violence but if violent acts were committed toward them they would respond even if lives were lost.

Plans call for bringing in 7,000, mostly street people, by January 1st.

Surrounding communities will not accept the "street people"

Mathis further explained that the street people have an entirely different cultural background and outlooks than others. New York and Washington, D.C. blacks are far different than Portland blacks.

Rajneesh are aware that it is not possible for a group opposing them to move enough people into Wasco County to stop their voting power. At present there are about 12,000 registered voters in Wasco County. The Rajneesh see themselves as capable of taking over Wasco County.

What they want is a meeting with the Governor and Attorney General and selected political sources for the purpose of recognition of their right to exist.

Recommendation by Mathis:

- 1. Several religious leaders in Oregon request the Governor to meet with them and invite the Rajneesh to attend. This would not project a direct meeting between the Governor and the Rajneesh to the public.
- 2. Governor then appoint a task force to inter-relate with the Rajneesh.

Violence Potential

Highly unlikely at Rajneeshpuram unless a major act of violence occurs at Antelope.

Rajneeshpuram is protected by the terrain and limited access. Antelope is unprotected from outside influenced violence.

The large scale integration of the street people, inter-racial, is not supported by non-Rajneesh.

State Police is the only law enforcement agency respected by both Rajneesh and non-Rajneesh and want the State Police. From discussion with the local ranchers Mathis doubts the Rajneesh would evern get to The Dalles with a local resident they arrest (re Oprey arrest).

Recommendation

State Police outpost at Antelope.

Mathis' agency will install and control a rumor control telephone system.

September 14, 1984

On September 13, Frank Evans a state Electrical Inspector, The Dalles, went into Rajneeshpuram. Was treated well, even though he ordered a temporary connection be disconnected. Went into the "street people" area without any problem.

We are now providing 2 patrols in Antelope area, basically noon-8:00 p.m., but overtime approved. Peace Force has been informed and is appreciative.

We will make one patrol through Rajneeshpuram Saturday and Sunday

We were informed that the FBI advised Rajneesh recently purchased 10 Uzi's and considerable amount of .45 and .223 ammunition.

September 15 & 16

Two patrols assigned to Antelope area. One patrol, once each day will traverse the county road thru Rajneeshpuram. Rajneeshpuram Peace Force has been advised and favor.

September 17, 1984

Visited with Mike Sullivan, Jefferson County District Attorney and Major Lamkin. Mike has maintained contact with Rajneesh-He requests 2 persons in the Attorney General's Office be kept abreast of activity so they could offer legal advice Recommended Chuck Pritchard and Byron Chatfield. Mentioned the 1984 Festival took in 12 million dollars. visited Antelope, was very quiet, no construction in progress. Were informed they worked until 8:00 p.m., Sunday. Don Smith, local resident indicated possible water problem. Antelope has summer water shortage and restricts use with shutoff normal 10:00 p.m.-6:00 a.m. Two recent wells were drilled dry. at one time utilized springs but were ordered by the state to dissonnect because of high bacteria. Smith's brother Earl operates a ranch with about $5\frac{1}{2}$ miles of common border with Rajneesh-puram. Contacted postmaster and Mrs. Bill Dixon. Their concern is not with the Rajneesh but with Sheela who is so unpredictable or with outsiders coming in and committing a violent act that would cause a Rajneesh reprisal. Mrs. Dixon related a recent unreported incident of 4 outsiders high on something that were held at shotgun point by their son until they left town. Bill Dixon related all local residents "were going south for the winter and wouldn't be back in the spring."

One member of the Rajneesh Peace Force was observed on duty and related everything was quiet. About 25-30 half modular units were observed on blocks at various locations about town. The construction site for the "man camp" is on a rise at the City limits cover considerable area and west side of town. are not marked for easy recognization. County shops at the south edge of town have 3 locked bays and gravel lot and could be utilized for an in-town command post. The city has only one restaurant, the Rajneesh owned Zorba the Budha. Two patrols. Sr. Tpr. Grammer and Wulf, were contacter. Both related very quiet but exceptional positive remarks by local ranchers for their presence. Dixons also very appreciative for added patrol coverage.

September 19, 1984

Congressman Bob Smith reportedly contacted the Governor's office offering to assist with organization of Federal agencies to aid the state.

Major Lamkin reported 12 new street people arrivals from Washington, D. C. and 29 persons left Rajneeshpuram by bus. Rumored that no more Puerto Ricans would be imported because they caused too much trouble.

Superintendent, Major Lamkin and I met with Gerry Thompson and Bob Oliver and briefed them on latest developments.

Last night a BF left Rajneeshpuram and was put on a bus to return to Pittsburgh, Penn. She got off the bus at Bend and returned to Madras. Ate a meal at a local restaurant and fiailed to pay full price so was arrested for Theft of Services. Said she left because she was roomed with 2 other women who were involved in sex parties and she later joined in. Last night there was a fight between 2 males, a black and white, and lots of confusion and possibly other fights so she left. Sheriff Perkins said Rajneesh later came and paid for the meal and he arranged for her release and transportation out of town. She identified herself as Janet Marie Sangrea @ Byrd and Bass, 12-22-48, 1139 Radman, Philadelphia, Penn. Said she had been on the ranch for 2 weeks. Later determined that she has extensive record in Philadelphia; Robbery, burglary, theft and prostitution.

Also reported that the subject from Terrebonne reported in September 13 incident was at Rajneeshpuram and created some type of incident. He has served time in Arizona for homicide.

Reports indicate about 60 people arrived yesterday and 12 left. Between September 12 and 20, 380 arrivals and 125 departures. There were about 500 already there prior to the 12th. Rajneesh informed Major Lamkin there were about 1500 Rajneesh in residence and 900 other people. This includes the people who pay \$250 a month to stay there. The "street people" importation should end in early October. The "street people" are all destined to Antelope housing. The \$250 people are identified by a red wrist band. Street people wear a white wristband for the first 2 weeks and then wear a blue wristband.

The recruiting program is slowing because news media coverage is creating lots of interest and volunteers.

15 busloads are expected in the next 3 days and each bus averages about 21 persons. California recruits are now starting to arrive. Major was informed by Rajneesh that new street people are told:

No liquor allowed

No drugs allowed

No problems allowed

If they have something in their background that could create a problem they should leave.

Some departed after this information.

He also discussed the Rajneeshpuram "loaded gun" ordinance. Was informed it was modelled after Portland City Ordinance. They do not intend strict enforcement, but primarily to prohibit anyone on foot with a loaded gun.

September 21, 1984

Teletype from Medford Police Department. Missing 15-year-old Police Cadet took parents vehicle - shotgun, two (2) rifles, and handgun and indicated he was going to Antelope to perform an assasination. Patrols, local agencies and Rajneesh Peace Force informed.

At present, Peace Force advise they have 10 police officers and 30 reserves. Antelope would have a separate Police Department.

We have been offered use of a two (2) bedroom 10×40 mobile home about five (5) miles west of Antelope. Fully furnished with telephone. Major Lamkin will make further inquiry.

Superintendent earlier requested Attorney General to call a meeting of the several Federal and State agencies with Rajneesh interest to a meeting. Has now been resolved and set for Wednesday, September 26, 1:30 p.m., in the Attorney General's office.

September 22 - 23, 1984

About 60 street people arrived over the weekend and 20-25 left saying they had been lied too. Related that they were encouraged to register to vote and the Rajneesh now operate a voter registration booth.

A Madras gun shop reported a white male with an eastern accent (unknown if eastern U.S. or Asian) made inquiry about purchase of several .223 and .243 rifles but did not actually make a purchase.

September 24, 1984

Assistant Chief Ma Dhiresha reported to Major Lamkin receipt of an anonymous letter at the Rajneesh Hotel in Portland. Letter warned that David Cooley, 10340 S. E. Harrison, Portland, along with Joe Greer, 241 N. E. 6th, Clatskanie, and James P. Terhune are organizing Vietnam Vets. They have hand grenades and land mines and will committ violence at Rajneeshpuram.

Portland Police Detective Newberg is working the case and will keep Major Witt informed.

Ontario Chief Jim Jones advises that the Rajneesh have 50 modular units in temporary storage at the Ore-Ida Truck Stop adjacent to I-84. Will be there about two (2) weeks. Were shuttled in from Challis, Idaho, and awaiting shuttle to Antelope. Two (2) Rajneesh on guard.

Major Lamkin contacted by Representative Bill Bellamy who advises that five (5) street people who left Rajneesh-puram have taken up residence at a Madras Mission and are meeting busses with arriving street people and attempting to talk them out of going to the Ranch.

Jim Lewis of BLM reports that he will have agents on Rajneesh leased BLM and other BLM land for deer season. In the past Rajneesh have permitted hunting on the leased land and operated information booths relative to open and closed areas. Sergeant Ross is checking further for clarification.

Rumor that Rajneesh will no longer pay for transportation of those street people who depart. Major Lamkin will contact Rajneesh for determination.

The 15-year-old Medford youth subject of September 21 report has been located in California.

September 25, 1984

Mike Sullivan has been informed by Rajneesh that the "street people" arriving as of today will not be receiving transportation back to where they came from. Last night Major Lamkin interviewed Joseph (nmn) Stan, black male, 7-3-61, 6-3, 260, Cleveland, Ohio, who appeared to be a mental case. Stan arrived yesterday and left shortly after arrival. Also a Carey Mathis, II-7-50, of Chicago, has an old gunshot wound and a Rajneesh departer threw a rock through a restaurant window in Madras yesterday. He then got off the bus in Bend and threw a rock through a bank window. Arrested and prints coming.

Major Lamkin attended a tri-county coordination/information meeting with all Crook, Wasco and Jefferson counties effected law enforcement agencies.

Confidential report from Tex Shively that about noon the Rajneesh received 96 AK47's and one million rounds of ammunition (ATF was advised). Also reported they now have about 500 sub-machine guns.

Peace Force advises they have two (2) Uzi's, two (2) AR 15 and ten (10) .38 revolvers. Major has information through Senior Trooper Wulf that earlier today Mrs. McCall of Antelope overheard radio transmission from the Rajneesh (8:30-9:00 a.m.) that the truck load of ammunition was ready to be moved.

September 26, 1984

Sergeant Ross contacted Rajneesh relative to hunting. They will not have information booths and are not very concerned. Hunting pressure has decreased -- 1981 - 200 hunters; 1982 - 50; 1983 - 15. They will have their security in the areas. Wasco County will have one (1) deputy in the area and we will have two (2) Game officers in the area. BLM will have agents on their lands.

About 9:30 p.m. last night, Mr. Opray called our office reporting Rajneesh Police entered his yard. Senior Trooper Shepherd was in the area and responded. Rajneesh reported shots fired from somewhere near Opray residence and the new construction site -- nothing found.

Modular unit installation is starting.

Marla Rae - Attorney General's office, advises she just received call from Joe Rainwater, Madras, 548-6402, Trailways Bus driver. Advises one departing from Rajneeshpuram asked him to notify authorities that several people were being held against their will at Rajneeshpuram. This same individual was interviewed by Dave Jones, Bend TV, 388-1718.

We will have an officer contact Rainwater.

District V information from Trailways of people in and out of Rajneeshpuram --

Call from Mr. Steve Baker, Minneapolis, Minnesota, (218) 26-2016, (home 326-3210) advised two (2) of his drivers from Simons Trucking were in Rajneeshpuram delivering construction material. They were heavily guarded but saw military installations and machine guns. Took some photographs. They can be contacted at States Industries, Eugene. Names -- Gerald Balling and Gordon Stoltz. Captain Duman will have someone interview them.

Normal Paulus advised that if the Wasco County Clerk decides to visit Rajneeshpuram to certify registered voters, she would need police protection.

ATF advised that they have confirmed purchases from dealers sales to the Rajneesh:

20 semi-automatic rifles (11 Uzi's, 4 AR15's, 5 assorted)

17,400 rounds .223

8,400 rounds 9mm

11,000 rounds .308

7,000 rounds .38 caliber

Discussion concerned coordination of information and activity of the various agencies surrounding Rajneeshpuram and the "street people."

Major Phillips advises that contact was made with the two (2) Simons Trucking drivers -- their story differs with their dispatcher -- when they entered Rajneeshpuram their truck cabs were searched for weapons. Were told if they had any they would be held until they left. Both drivers got lost in town, drove around and took some photographs. They did observe some people with holstered sidearms. Copies of the photographs were obtained.

September 27, 1984

Marla Rae advises that she has several full and partial boxes of candy received from Laura Bentley and her associates of The Dalles. Mrs. Bentley is anti-Rajneesh and candy came from suspicious sources. Identification Bureau will pick them up, process and forward to the crime laboratory.

Major Lamkin advises that there were 103 new people into Rajneeshpuram yesterday and 161 out. Otherwise quiet. Did have a request from Ma Barkaha for CCH requests -- tried Rajneesh ORI and both no record.

Superintendent met with Governor and briefed latest developments. Also met with John Mathis, Bob Lamb, U.S. Department of Justice, Community Relations Services. Mathis has been in frequent contact with Rajneeshpuram, particularly Sheela Silverman.

Talked with Ester McAmis, Soap Lake, Washington, (509) 2461315, who is a de-programmer for cults, etc. She visited Rajneesh-puram for 3 days after the July Festival. Said the program is designed to dis-orient people and is very professional. She would not be surprised that the Bhagwan is either drugged or hypnotized and held by the group leaders.

September 28, 1984

ATF last night raided USI Weapons Sales, 2612 - 122nd Avenue, Portland, with search warrant. Operator attempted to trade 11 machine guns and seven (7) silencers to an undercover agent for one pound of cocaine. Seized those items plus 17 additional machine guns and several silencers and all records. They suspect that sales may have been made to Rajneeshpuram but will take a few days to complete the record search.

September 29 & 30, 1984

Quiet

October 1, 1984

Major Lamkin advises up to 50 people left the ranch last night, all had tickets.

Bend office received approximately 3,000 calls on the 800 number over the weekend. Many were people just expressing an opinion. We had as many as 3 people answering the phone. During peak times were receiving about 50 calls on hour.

Information from Marion County Sheriff's Office that Robert Imel, Salem, and former police officer who is now a gun dealer recently sold 27,000 rounds of .223 to Rajneesh. When contacted by our officer Imel said he had not sold anything, however the Rajneesh were inquiring about weapons. He referred us to Ed Tulleners, Western Wholesale, 4800 S.E. Macadam, Portland, who may have sold to Kenney Leonard (K & R Reloading), phone 236-8184, who then sold to Rajneesh. Portland office determined that Tulleners received a call from Allen at 489-3411, ext. 345, who inquired about purchase of Galil Assault refles - was specific that he wanted:

MR361 Ar - 223 cal. - priced at \$1,000 MR331 AR - 308 cal. - priced at \$1,100

Tulleners had them in stock but would sell only to Federal licensed dealer. Allen said he had applied for license and wanted to discuss a price break for 10 of each. Has since called back twice but still no license. Galil is an Israeli semi-automatic assault rifle. Has a folding stock and magazine capacity of 40 rounds.

Captain Noland advises that Ma Barkha estimates 3200-3000 population, however Ma Isabell gave the following:

1700 - Rajneesh resident members

1200 - Paid visitors at \$250 a month

500 - Visiting Rajneesh (training, univ. students, etc.)

2100 - street people

5500 - total

The "man camp" now has 16-18 units in place.

October 2, 1984

Film on cults was shown at the Antelope Community Church last night. About 25 people attended. Unknown if any Rajneesh were in the audience.

Major Lamkin and Lt. Thiess will attend a meeting at The Dalles tonight. Anti-Rajneesh, Rep. Fawbush is a speaker.

Rep. Fawbush has requested we investigate an inflammatory letter mailed out using his letterhead stationery.

Information from Bend that Rct. Kevin Bennett, Roseburg, told his brother that one of his recruit school room-mates was a Rajneesh. Bennett advises that at BPST while he worked for LaGrande P.D. he was a room-mate with one of the Rajneesh Peace Force.

Byron Chatfield advises they have information of a vigilante, paramilitary group formed to kill Sheela and other Rajneesh leaders. Said Paul Keller was investigating. Told him that we had officers to assist and we should be involved. Said Paul would check it out and then they might ask for assistance.

We are aware of a pamphlet requesting donations to support a campaign against the Rajneesh. Return address is a P. O. Box in Rogue River. Medford office will make an investigation.

Visited with Tom Casey, INS, Portland, for background information.

October 3, 1984

Major Lamkin advises the meeting at The Dalles was a political issue. About 1500-2000 attended. He did answer some questions. Wasco County people oppose the Albany interference in the voting issue. Carry Ann Willis, Congressional candidate gave a very inflamatory talk based on assumptions, etc.

Captain Noland advises that we received a call from the ranch about 8:00 p.m. last night requesting we come down and arrest a confirmed fugitive from Texas - Forgery. They were told to go ahead and make their own arrest and we would assist if needed. Nothing more heard on this issue.

Reported fight in the "street people" food line.

Apparently very few, if any, street people left in past 24 hours.

Marion County Sheriff's Office reports an anonymous phone call concerning an anti-Rajneesh group coming to Salem. No other information, is probably the Albany group to protest at the Capitol.

October 3 (Continued)

Byron Chatfield, Attorney General's office, advised that Sister Frank, St. Mary's, Portland, 228-4397, has 3 street people at the church. Captain Davenport will arrange for an interview.

We have offered and Byron has accepted Sgt. Tenderella to assist with the Attorney General's Rajneesh investigation.

Information from Lt. Snyder that FBI Agent Bart Gori, Portland, advised at 10:55 a.m. he received a call from Jose Flores, Jr., who said he was calling from Rajneesh (Antelope). Said he was from Chicago and was not being furnished a bus ticket back. Claimed a security guard was with him. Gori then talked to a subject named Apperson. Could hear Flores yelling in the background for help.

We contacted Ma Barkha who advises the incident occurred at Walt Whitman Grove, Rajneeshpuram. Our patrol had made contact with Ma Barkha and is investigating.

Bend Police Department advises that on October 1 a resident in the suburbs found a number of leaflets in her yard and in the Deschutes River. Were apparently dropped during the night or early morning from an aircraft, although no aircraft reports or other information was received.

Contacted Jerry Tate, ATF. He advises that there are about a dozen Class 3 Federal firearms dealers in Oregon that are authorized to deal in automatic weapons. Because this is a tax-base law, he is prohibited (criminal offense) from releasing their identity. However, he has been in contact with them concerning any Rajneesh purchases. Also all sales to the Rajneesh have been flagged by ATF Headquarters, Washington, D.C. and will be reported to us. The September 28 information on USI Sales only revealed previously reported sales to the Rajneesh.

Captain Rothermel advises that the Rajneesh still have about 15 modular units at Ontario, being moved by a Springfield firm. Still some incoming from Idaho. Also they will check a rumor that the Rajneesh are interested in purchasing the Beck Ranch at Westfal, northwest of Vale.

October 4, 1984

Major Lamkin advises that from his perspective the "hotline" meeting yesterday at Antelope was not productive. Extensive press coverage and was slanted one-sided toward concerns expressed by the Rajneesh. Another meeting is scheduled for October 10. Federal Department of Justice, John Mathis, advises they have no money and he would attempt to get volunteers from Antelope to man the center.

Bob Wilson, Portland Police Bureau, reports that Rajneesh have purchased 6 model 19 Smith and Wesson revolvers. Report came from the dealer through normal reporting channels.

Hotline calls at Bend have reduced to a manageable level - can now provide service with the regular one person swing and graveyard dispatcher. "Man camp" completion date is now estimated about November 1.

Call from a reporter for a Jacksonville, Florida newspaper. Reports Rajneesh recruiters now in their city. 13 "street people" left this morning accompanying 26 from the Miami area.

October 5, 1984

Byron Chatfield is in receipt of correspondence from Margaret Scranton, Tygh Valley, that she received one of the Anti-Rajneesh campaign fund phamplets and obtained the license of the delivering vehicle. Deputy Gary Crow investigated. Major Lamkin will cause a check with Deputy Crow.

Estimated 3000 "street people" now at Rajneeshpuram. About 100 arriving daily and about 60 leaving each day.

Washington State Patrol Detective Hendricks, Organized Crime Section, phone 753-0440 or 753-327, called with inquiry about Rajneesh, drugs and guns. Said two recent stops in Washington were Rajneesh, polite, no evidence of any wrongdoing. Said press information they had caused some concern because of the weapon implications. Reported rumor that Rajneesh had recently purchased a large parcel of land in Vancouver, B. C.

October 6 & 7, 1984

Accompanied Major Lamkin, Captain Noland, General Osbourne and Colonel Lockwood to Rajneeshpuram. The checkpoints were each manned by a man and woman, one private type vehicle at each, both intently observed our vehicle as we passed. The checkpoints are well built round type construction, attractively painted and with large glass windows that allow visual observation to the sides and front, and are set back from the county road approximately 20 feet. We passed three checkpoints before arriving at Rajneeshpuram. Just prior to entering the city observed a temporary canvas walled structure without roof. Appears this is probably where "street people" either enter or debark or both. When we left there were about 40 persons and baggage at this location and appeared they were awaiting to depart.

The county road parallels the airport runway. Four large planes, the Britain Islander and a small helicopter were observed at the runway apron.

We contacted Chief Barkha at the police-fire-communication center building. She escorted us around the ranch to various locations and returned to the main area for lunch, where we were joined by Mayor Krishna Deva. Krishna Deva's complaints were directed toward the Attorney General and then he settled down and was cordial. We stood in line with several thousand as the Bhagwan drove by on his daily tour. Security for the Bhagwan is very tight. His car is preceded by a Peace Force vehicle, with 2 Peace Force members. An AR-15 type weapon was observed in the window rack of the Blazer. Two security people on foot, one armed with an Uzi followed the Bhagwan's vehicle and bringing up the rear was a Mercedes 4-door with 2 people. The 2 foot security entered the Mercedes at the end of the worship line and all vehicles departed together.

Chief Barkha related that the Peace Force recently acquired some AR-14 (mini 14) rifles and they now have 10-14 semi-automatics. She also introduced Ma Prem Sona, newly appointed as Assistant Chief, replacing Ma Khiresha who has been appointed Chief at Rajneesh (Antelope).

Construction is continuing at Antelope. Several units have been placed and it appears that the "man camp" will extend nearly to the county road just west of its junction with Highway 218.

We inspected the Highway Division facilities at Shaniko. There is ample parking space. The building is 3-bay, unheated, and 1-bay cement floor with heat. This facility would serve very well for a forward command post in event of a problem at Antelope.

October 9, 1984

Major Lamkin advises quiet during the night. Trailways bus delivered 66 to Rajneeshpuram and took out 34.

Rumors are now increasing about street people being dumped in communities. Have proven false so far.

October 10, 1984

Major Lamkin advises that Lt. Thiess was just notified by Sheriff Brown, Wasco County, that he may need assistance. Reported that Rajneesh will be bringing in several busloads of "street people" to register and the County Clerk will reject their registrations. Major will observe by air and patrol for number of buses expected to arrive at 9:00 a.m.

Greg McMurdo advises that a press release will be forthcoming. Secretary of State will hold a conference Friday at 11:00 a.m. and announce immediate rejection of new registrations statewide. Action is based upon ORS 247.174. When rejected the applicant is automatically afforded a hearing at later date to determine if qualified. The press release announcing the Friday press conference specifically excludes Ma Anand Sheela.

At about 11:00 a.m. one bus with approximately 20 people arrived at Wasco County Courthouse led by Jay Ananda. County Clerk Sue Proffitt rejected their registrations. After short verbal confrontation the bus and passengers returned south.

Report that 48 "street people" were dumped in Portland last night. Captain Davenport caused check with Baloney Joe's; 48 is believed the total number over the past 3-4 weeks. None were located today to interview.

October 11, 1984

Met today at Bend with District Commanders to brief them on the Rajneesh situation and review emergency contingency plans.

This morning 120 people were incoming and 100 were scheduled to leave.

Twenty-nine were eventually brought to Portland and 22 agreed to an interview by our members.

44:25 p.m., K.D. called, advising that a lot of people were upset with the Wasco County decision to reject voter applications and that 1000-1500 Rajneesh and friends would hold a peaceful demonstration in front of the Capitol building on Friday morning. If any entered the Capitol to attend the

the Secretary of State press conference it would only be a few persons. No firearms would be brought except the normal sidearms by 2-4 Peace Force officers who would accompany. The contingent will depart Rajneeshpuram by bus between 4 and 5:30 a.m. Friday. At about 10:00 p.m. a call was received from Serveeta, Rajneeshpuram dispatch, with a message from Chief Barkha that the Friday demonstration was cancelled.

October 12, 1984

Confirmed with Trailways and Greyhound that bus leases for today were cancelled. Seventeen Rajneesh flew into Portland, nothing unusual.

Last night at 9:15 p.m., Willowdale Cafe notified us that two intoxicated subjects had just left stating they had explosives and were en route to Rajneeshpuram to take care of those "redshirts." Rajneeshpuram Peace Force was notified. At 9:27 p.m. our patrol stopped them at Rajneesh:

Arrested were:

Edgar Dawayne Perry, 4-24-58, DUII Clyde Edward Bringham, 7-28-63, Resisting Arrest

White '72 Ford Pickup, JJM302.

No firearms or explosives were found in the vehicle. Subjects lodged in Wasco County Jail.

Major Lamkin advises the Rajneesh "man camp" appears 40-50% completed. Construction is underway on a large sewage system, north side of the area.

The Dalles will commence a 24-hour hotline rumor control at 8:00 a.m., October 13. 1-800-452-8573 is in addition to the Bend hotline 1-800-452-6824.

October 12 (Continued)

Captain Davenport advises a bus of 20 street people arrived in Portland about 1:00 a.m. this date. They will interview them this evening.

Another bus due in about noon Saturday.

Have been informed that the Salvation Army purchased transportation for 44 street people.

Commencing this date we have established 2, 24 hour patrols from Bend to The Dalles and 1, 24 hour patrol Government Camp to Warm Springs. These are in addition to the 24 hour patrol previously established in the Rajneesh area.

Radio station KXL ran a brief interview with subject identifying himself as a member of The Committee on Terrorist Activities regarding volatile situation with Rajneesh. Captain Davenport determined that the subject is Ryan Quade Emerson, President, International Research Center on Terrorism, Hollywood, Florida. Stated he is considering a branch office in Portland or The Dalles. Emerson writes a bi-monthly report on International Terrorism and recently wrote a book, "Who's Who in Terrorism." FBI Portland ASAC Chuck Archer has no information on Emerson and never heard of his group.

October 13, 1984

Several Rajneesh-owned buses and vans observed coming into Rajneeshpuram. Three Saturday night may have originated at Rajneesh.

October 14, 1984

Captain Davenport advises that on Saturday (October 13), 30 street people arrived in Portland from Rajneeshpuram and 42 new arrivals left for Rajneeshpuram. Persons leaving Rajneeshpuram are reportedly being told that there is a lot of violence in Portland toward them and they will be beaten up. Ron Ellis, a former Rajneesh "street person" has set himself up as a contact and is screening street people in an attempt to transport them home. He is responsible for organizing the pickets at the Rajneesh Hotel, Portland. Salvation Army has transported 75 from Portland. Greyhound Bus Lines report there are no more scheduled arrivals for new street people.

October 17, 1984

Captain Davenport advises that last night 2 street people were brought to Portland and left. They stated there were several that wanted to leave Rajneeshpuram but were fearful of being "dumped" in the desert in the cold. Greyhound has been informed that Rajneesh will not be needing an outgoing bus for at least one week. Rajneesh reportedly now commencing a "Winter Festival."

Captain Noland advises has been quiet as of October 15. Three-four street people were provided tickets and departed by bus.

About 6:00 p.m. Gerry Thompson reported a call from Colonel Riley, Salvation Army, that two buses with 20 & 27 street people had been deposited in Portland at about 4:00 p.m. and will be at the Harbor Light, Portland. Portland office will contact them and interview. She also related that K.D. had called her frequently all day, related that he was "sitting on a bomb."

October 18, 1984

Lt. Howland advises that contrary to news media reports that 150 street people were deposited in Portland last night, the actual count was 47. All were interviewed. They related in substance that they estimate 1 to 2 thousand street people still in Rajneeshpuram (we estimate 3000) and there were about 500 that wanted to leave. As of October 15 no new street people have come in and no more scheduled.

Major Lamkin advises that many voter registration cards were address changes within Rajneeshpuram. Yesterday Lt. Thiess was advised by Rep. Fawbush that the Governor's office was paying for some of the street people bus tickets "under the table."

Last night Rajneeshpuram Peace Force arrested one in Rajneeshpuram for Disorderly Conduct and transported him to Wasco County Jail at The Dalles.

Rajneesh Peace Force recently has shown interest in our weapons, asking Troopers what we carry in our cars, etc. Also have made inquiry about our Armorer, training, selection, etc.

Major spent October 17 visiting in Rajneeshpuram attempting to impress upon them the importance of informing us of the attendance at functions, etc. and including the depositing of street people.

Interesting during the discussion, Ma Dhiresha asked him how we would handle mass arrests in Salem, where we would house prisoners, etc.

October 15, 1984

Some calls coming from street people at Rajneeshpuram saying they want out. If evaluated critical we contact and then if substantiated advise Rajneeshpuram Peace Force.

The Dalles hotline impact not as great as expected - 23 calls Saturday, 18 Sunday, and 10 up to noon today.

Bend hotline is also under control and not inundated at this time.

Captain Duman advises that on October 12 The Shooting Shop, firearms dealer in Eugene, was contacted by a Rajneesh identified as "Roger." "Roger" wanted to know if they would accept delivery, through the shop, from out-of-state wholesaler of 10 Uzi semi-automatics for subsequent resale and delivery to the Rajneesh. "Roger" also requested a price list on thousand round sales of 9mm and .223 ammunition and two different models of .38 cal. revolvers, models 19 & 659. They will sell to the Rajneesh if recontacted.

October 16, 1984

Last night Pullman, Washington Police Department made inquiry on Malcomb S. Shankle, black male, DOB 12-12-47, who they recently arrested for disorderly conduct and then released to Eastern Washington State Hospital. Shankle claimed to be a Rajneesh. Records reveal Shankle was arrested in Madras on September 17 & 19 for misdemeanors and on September 24 was released to Eastern Oregon State Hospital. He has a lengthy FBI rap sheet since 1964. Apparently was one of the early street people and rejected from Rajneeshpuram.

The October 3 reference to possible Rajneesh interest in purchase of the Beck Ranch at Westfall appears to be a false rumor. A Colorado Attorney has been negating the possible purchase for over one year.

The October 2 reference concerning donations request pamphlet to P.O. Box 289, Rogue River, has been investigated. The P.O. Box is to T. C. Restaurants, owned by Timothy Cummins, whose father, John Fredrick Cummins, says he is responsible for the distribution of the pamphlets to residents near Rajneeshpuram. He claims to be an agent for a group whose interest is

intelligence gathering and non-violent. He would not identify the group, "AC" listed on the pamphlet or what national magazine they intended on using to advertise their campaign. Mr. Cummins advised that the group plans to infiltrate Rajneeshpuram to determine if any laws are being violated and if so call attention to the responsible agency. The group supports law enforcement and is aware of law enforcement legal restrictions which they don't have to abide. To date they have not received any donations.

On September 27 a black '84 Chevrolet sedan, CYA577, was observed in the Antelope area. Informant reported the driver as a concern. Registration is to John F. Cummins, 11-29-32, of 5969 Table Rock Road, Central Point. Mr. Cummins is not of record CCH or traffic.

At about 2:00 p.m. a Rajneesh DC3 landed at Salem. Three Rajneesh were waiting and a party of about 9 left the plane. Included were Sheela and K.D., who held a news conference on Channel 8. All then departed to St. Paul's Episcopal Church (Bob Davis' funeral?). At about 4:00 p.m., Sheela and several others departed by plane.

October 19, 1984

Seven street people left in Portland last night.

State Board of Pharmacy reports information of abnormal amount of haldo, an anti-psycotic drug, purchased by Rajneesh during September and October.

Complaint from street people in Portland that a female in Rajneeshpuram alleged attempted rape. The subject was turned over to the Rajneesh Peace Force and apparently no action taken.

On October 18 a deceased street person was found dead from exposure at Government Camp. He had exited the bus and was later rejected from a tavern. Had in his possession a prescription drug bottle reportedly issued by a Rajneesh doctor containing anti-depressant drugs.

October 20, 1984

Teletype and Major Lamkin reported estimated 140 street people dumped in The Dalles this evening. Transport was by bus and vans. Later determined the count at the Salvation Army was about 60. Reports that more were en route failed to materialize. In addition, 57 with tickets were deposited at Madras but they all left by buses. Rajneesh officials failed to cooperate by pre-notice of removal and destination of these people so we directed patrols to stop and check every bus and van in attempt to determine if any street people were in-transit and destination. Interviews were being conducted at The Dalles.

October 21, 1984

No additional street people were reported last night. At 6:00 p.m., Captain Noland advised that K.D. had just informed him that 20 street people would be transported to Portland tonight. We alerted Harbor Light Center through the Portland office. Also 12 would be brought to Madras but they would have bus tickets. K.D. also discussed concern with our stopping of vehicles exiting Rajneeshpuram and we advised we would desist as long as the Rajneesh furnished prior notice of street people removal and where they would be dumped.

October 22, 1984

During interviews of street people at The Dalles Saturday night members received an allegation by a female of being beaten by Rajneesh when removed from the ranch and her husband also beaten when he came to her aid. Lt. Renfrow will follow-up through Rajneesh Peace Force.

Captain Rothermel advises that this morning Eastside Transport and Lemon House Moving removed about 8 of 20 modular units from Ontario. It appears that these are the last of the "man camp" from Challis, Idaho destined for Rajneesh.

Rajneesh Dr. Shinio (phonetic), Madras, had his personal car damaged over the weekend. Investigation by Madras Police Department.

Detective Rutledge advises he has a typed "threat letter" sent to KATU-TV. The letter threatens chemical poisoning at Rajneeshpuram unless the Rajneesh withdraw candidates for the Wasco County election.

Captain Noland advises Sr. Tpr. O'Neill is en route to Rajneeshpuram to examine a possible letter bomb.

This is the second suspicious package response. Last week Sr. Tpr. O'Neill responded and package contained white powder.

Teletype at 1:16 p.m. from Captain Noland advising that about 1:00 p.m. Rajneesh left Rajneeshpuram transporting 25 street people to Portland who do not have bus tickets.

At about 4:30 p.m. Colonel Lockwood, Military Department, reported an anonymous phone call to The Dalles Armory. Female caller stated that "if any Rajneesh are allowed to come into The Dalles Armory to register, they will be sorry, we have arms."

6:30 p.m., Colonel Lockwood reports another anonymous call received by Sgt. Bugby, The Dalles Armory. Male reported overheard a threat at Albany; if Rajneesh appeared at the registration hearings violence would occur, mentioned explosives.

October 22 (Continued)

Bend teletype at 6:46 p.m. reporting 35 street people to be bused to Madras tonight. All have bus tickets home. Seven to be transported by van 6 to Portland, 1 to The Dalles, no tickets.

Major Lamkin received call from K.D. regarding attempt to transfer voter hearings to Rajneesh. Was assured if court transferred we would assist with nearby security.

At 10:49 p.m. a teletype reporting another 10-12 leaving Rajneesh en route to Portland some with tickets.

Teletype at 10:25 p.m. advising the suspected bomb was Rajneesh beads apparently mailed from Salem.

October 23, 1984

Voter registration hearings commenced at The Dalles Armory today. Most involve non-Rajneesh. Fifteen Ranjeesh have arrived and other than some name calling by nearby tavern patrons, there were no incidents. City and county have several uniformed officers, outside and inside the Armory. Only those with scheduled hearings are allowed in the building. Secretary of State Paulus and Wasco County Clerk Sue Proffitt are observing. News media well represented.

Captain Rothermel advises that a member contacted one of the modular unit movers near Ontario. Reported that all the units should be moved to Rajneesh by the coming weekend.

Lieutenant Renfrow and Detective Corson went to Rajneeshpuram - follow up on cases. Corson is conducting death investigation on the street person found at Government Camp October 18 and Lieutenant Renfrow allegations of assult and attempted rape.

Major Lamkin advises that the voter registration hearings were completed at 2:15 p.m. and Normal Paulus has departed. Three hundred non-Rajneesh were afforded hearings and none rejected. Fifteen Rajneesh were examined with two rejections.

At 5:35 p.m. Major Lamkin advised that K.D. had just informed him that 25-30 street people were enroute to Portland. Some have bus tickets. Also, K.D. is enroute to Portland by car.

October 26, 1984

Teletype last night advising that 18 street people with tickets were being transported to Madras.

Major Lamkin advises that Ma Prem Sunshine gave the following population:

Street people - 2500-3000 Total population - 6500-7000

Statesman Journal this morning quoted Swami Prem Siddah of the Information Bureau (Sunshine's Bureau) that street people population is 3200-3300. Major Lamkin will discuss with Sunshine. Our figures reveal that from October 20-25, 334 street people have departed.

October 22 log entry referred to vandalism of Dr. Shinio's (Dr. Swami Shumyo) vehicle in Madras. Two subjects have been arrested by Madras police on felony charges - Tod Dunten, 19, and Chris Hearn, 18, both of Madras.

Teletype at 2:18 p.m., advising 23 street people en route to Portland, ETA 4:00 p.m. Some have tickets.

The Dalles City Manager, Del Ceaser, requests that he be notified if we hear from the Rajneesh that they are or are not intending to attend the November 1 and 2 hearings.

Greg McMurdo advises that 1800 voter registration hearings, which include 1000 Rajneesh, are scheduled for November 1 and 1900, all Rajneesh, are scheduled for November 2. Hearings will commence both days at 9:00 a.m., lunch break on the premises noon to 1:00 p.m., and dinner break on premises $5-6:00\,\mathrm{pm}$. At conclusion that evening or night the hearings officers will be bused back to Portland. Merideth Wylie of Albany is being supplied as an emergency hearings officer at the Wasco County She will be available only Courthouse October 29-November 6. upon reference from the County Clerk. She will arrive on October 28 and depart November 7. Mr. McMurdo requests her presence be held in security. She will be lodged in room 424 at the Tapadera Motel and can only be reached by phone through the room number or through the County Clerk. Major Lamkin will have her contacted by plainclothes officer to advise her that we can assist with problems. Sheriff Brown will be informed of her presence.

Major Lamkin will attempt to get a November 1 and 2 bus schedule from the Rajneesh.

October 26 (Continued)

Law enforcement meeting at The Dalles is scheduled for 1:00 p.m., Tuesday, October 30. Colonel Lockwood and I will attend.

Gerry Thompson has been advised by John Mathis that we should expect demonstrations by the Rajneesh in The Dalles until the hearings are concluded. Major Lamkin will advise city police department and sheriff's office and discuss with K.D.

We are now informed by the Rajneesh that present population is 6000-6500 of which 2500-3000 are street people.

On October 17 the Rajneesh reported street people population of 4200 and no more incoming. We have confirmed the following departures since the program commenced about September 1 through October 26:

615 - Madras, Rajneesh ticket purchases.

360 - Portland, Salvation Army ticket purchases.

84 - The Dalles, Salvation Army ticket purchases.

43 - Madras, Harvest Mission ticket purchases

Estimated 400 have left without any paid transportation.

In the event of mass purging of street people we have determined that Jefferson County will activate their Emergency Services and have pre-planning in place.

Wasco County has some planning and when we determine who is in charge we will notify Gerry Thompson so she can advise Dave Fiskum.

Military will conduct a briefing at 2:00 p.m., Tuesday, October 30 at Salem Armory. Superintendent Williams has been invited.

October 27 & 28 No reports

October 29, 1984

Lt. Howland advises 19 street people came into Portland at 5:35 p.m. on October 28, without notice. They relate that all street people in Rajneeshpuram have been moved from four camps into one, Walt Whitman, which contains 200 A-Frames and 150 tents. Three persons assigned to each unit. They estimate 1000 street people now at the ranch which is far below our estimate and reported 2500-3000. Also report a 4-day birthday celebration for the Bhagwan commencing December 7 and have been told 15,000 expected to attend. Confirming article reportedly in a recent issue of the Rajneesh Times newspaper.

These people also report that upon receipt of voter rejection notice they are requested to turn in the letter. Rajneesh inform them that they will file a class action lawsuit and the street people will share in any award.

Up to now the Peace Force has been polite but they are now showing force. When street people leave they report their prescription bottles either have the label removed or obliterated. This commenced after the death investigation of the person at Mt. Hood. (William Henry Allen, Oct. 16).

Military Department has requested a bomb check of The Dalles Armory mornings of November 1 & 2. We will assign Sergeant Zimmerman.

Sergeant Zimmerman has request from Rajneesh to check a tampered mail order box received today. Their explosive dog indicates explosives. Sergeant later advised the package was negative. This is the third false alarm from this dog. We will discuss with Ma Barkha on October 30.

A 79-year-old male, Forrest Wilford Goff, missing from Wallowa County since September 8 reportedly has been seen at Rajneesh-puram by several street people. Rajneesh report they are unable to locate him. We will re-contact the Peace Force.

As of Friday, October 26, all modular units for the "man camp" have been removed from Ontario. This supports estimated completion at Antelope by November 1. We should expect occupation around November 6-7.

October 29 (Continued)

Major Lamkin was advised that 15 people were being removed to Madras and 5 to Portland. All have tickets.

Major also received a call from K.D. He reported that Bruce Duane Archer, arrested at the Rajneesh Hotel by Portland Police Bureau on September 28, told the Rajneesh that motorcycle gangs were planning to go to Rajneeshpuram in a few days to create problems. Portland office will attempt to contact Archer for interview. K.D. also requested we transport an uncut video tape of Sheela's announcement today to Governor Atiyeh so he can get the "full story." Major will deliver to me at The Dalles October 30.

In event of mass dumping of street people, Hugh Holt, Wasco County Emergency Services will arrange for meals and lodging. (Betty Maudlin to inform Gerry Thompson for instructions to Dave Fiskum).

October 30, 1984

At 9:55 a.m. Captain Rothermel advised by phone that Sergeant Parker had received a telephone call at his home last night from the Rajneesh people. He was not sure specifically who was calling, however, thought it might have been Sheela's voice. The caller advised that they were making a survey. Sergeant Parker advised that most of their questioning surrounded the Indian Treaty rights and, specifically, Indian fishing and what he thought about Norman Paulus' court action against them. Based upon the conversation, Sergeant Parker felt that the caller knew he was a State Police officer. The information was relayed to Captain Noland by phone who will check with K.D. to determine if they are actually making a survey.

At 10:25 a.m. Captain Noland advised that K.D. from the ranch advised him by phone that they were having a meeting tonight to determine if they were going to have members actually attend the hearings. His comment was, "It doesn't look like the roads between Antelope and The Dalles will be very busy Thursday and Friday." He will keep District V Headquarters advised as to what their decisions are.

At 10:45 a.m. Captain Noland advised that K.D. informed him that their legal firm is making a study to determine their fishing rights around the ranch. K.D. vaguely informed Captain Noland that they were making some random telephone calls.

At 4:45 p.m. Captain Noland advised that he received information from our Portland office that the head of the Guardian Angel group will announce at the 5:00 p.m. news tonight that they plan on picketing the Rajneesh Hotel in Portland and place a monitoring post at the ranch.

Colonel Lockwood and Colonel Pankratz met with Wasco County law enforcement agencies regarding security and plans for November 1 and 2. Oregon State Police will have 20-25 members in the area and on patrol or normal duties. The Dalles Police Department will have six uniformed officers outside the Armory. In addition, an observation post of one city and one State officer will be set on the roof of Payless Drugs across the street to observe the outside of the Armory.

October 30, 1984 - continued

Wasco County Sheriff Brown and five uniformed deputies will be inside the Armory. Only those scheduled for hearings and authorized officials will be permitted entry. News media will be contained to certain portions. Major Lamkin and three other out of uniform State police members will be inside the Armory for security and intelligence.

October 31, 1984

Captain Davenport advised we have contacted John McKeim, West Coast representative of the Guardian Angels. They plan a halloween night demonstration at the Rajneesh Hotel in Portland and also hinted of some type of action at Rajneeshpuram but refused to elaborate. Major Lamkin advises that at 11:50 a.m., October 28, a cadet at The Dalles observed 4 Guardian Angels and they informed him they were en route to Rajneeshpuram.

K. D. informed Captain Noland that to the best of his knowledge they would not attend the November 1 & 2 voter hearings. He was informed of our basic security plan.

The suspect referred to September 27 has been checked with negative results and no evidence of tampering.

We have determined that between March 20 and October 8, 148,950 pounds of blasting powder and dynamite and 648 blasting caps have been delivered to Rajneeshpuram. Purchased from Pacific Powder, Newberg, by J. Arlie Bryant, Inc., 200 W. 6th Street, The Dalles. Reported use is road construction.

Teletype report that 20 street people left Rajneeshpuram 1:00 p.m. en route to Portland. Some have bus tickets.

Guardian Angels National leader Curtis Sliwa is in Portland nad has announced that his group may go to Rajneeshpuram and stop Rajneesh buses to protest "dumping" of street people.

November 1, 1984

Major Lamkin advises that Ku Klux Klan material was distributed, primarily in the business district, The Dalles, during the night.

Our aircraft flew the ranch area about 7:00 a.m. and no activity at all.

At 9:00 a.m., one bus was observed but appeared to be the regular shuttle.

Voter registration hearings commenced at The Dalles without problems.

At about 2:30 p.m., no Rajneesh had appeared so the majority of the hearings officers have departed. Some previously scheduled hearings will continue until 9:00 p.m.

Michael Stoops of Baloney Joes, Portland, has announced a meeting in Madras tonight and it is reported the Guardian Angels will attend. We will have a member in attendance.

Ma Prem Sunshine now reports that their population has stabilized. They estimate 2500 homeless and 6500 total population at Rajneeshpuram.

It now appears that a hearings officer will be going to Rajneeshpuram on November 2 to handle handicapped and disabled.

On November 6, Arno Denecke and Herb Schwab will be observers at Rajneeshpuram precinct, and Bob Straub and Jacob Tanzer will observe at the Rajneesh (Antelope) precinct. Both teams will travel to and from the Madras Motel by motorhome. Two State Police drivers, Sgt. Adkins, Madras, and Sgt. Dotson, Bend, have been assigned. They will have communication by portable radio. Sheriff Bob Brown will have a uniformed deputy at each precinct and I deputy on patrol in the area. We will also have patrols in the area. Hardy Meyers and Professor McClanahan will be observers at The Dalles and no additional security has been requested.

At 6:42 p.m., we were advised that 22 street people were en route to Madras. Twenty have bus tickets.

A member attended the evening meeting in Madras conducted by Michael Stoops. His presentation was low key and urged support of local social services. Curtis Sliwa, National leader of the Guardian Angels, accompanied by 4 others, gave a more inflammatory presentation, condemning the Rajneesh for "dumping" street people. About 30-35 people attended.

November 2, 1984

Major Lamkin advises very quiet at The Dalles. Only a few local people attending hearings. If nothing develops by noon, he will commence sending troopers to their home stations.

There was a mailed package received by Sue Proffit at the Wasco County Courthouse which obtained obscene material. Will be forwarded to us for comparison. Mailed from Salem.

Ma Prem Sunshine has revised her street people population she reported yesterday. Now reports 2350 at the ranch.

1:00 p.m., K.D. reports a bus load of 18 street people is leaving en route to Portland. Most do not have tickets.

Guardian Angels have a camp trailer two miles down Cold Camp Road toward Rajneeshpuram, however no one is around. Captain Noland will attempt personal contact. Major Lamkin advises that D. A. Bernie Smith suggests that if the Guardian Angels block the road they be charged with disorderly conduct and he has arranged bail at \$10,000.

Curtis Sliwa advises he is organizing a "funeral procession", minimum of 40 people and 12 cars. Will leave Baloney Joes at noon Sunday, drive past Capitol and Governor's residence. We will monitor and have additional members at the Governor's residence.

Sliwa has agreed to meet with me at General Headquarters, 4:00 p.m., Saturday. Will attempt to dissuade his activity rel Rajneesh.

At 4:03 p.m., four Guardian Angels arrived in Antelope. They are staying at the Kuhlman residence and will use the trailer on Cold Camp Road as an observation post. Captain Noland contacted them. John McKeim of Los Angeles identified himself as the Western Director, said they may have up to 25 Guardian Angels in attendance. Added they probably won't bother just I bus coming from the ranch but will take action if several buses come out with street people.

November 3, 1984

At 2:05 A.m., a suspicions briefcase and nearby duffle bag was found at the front fence of Governor Atiyeh's residence. Removed by Salem Police Department bomb squad. Contained clothing and I.D. to John Michael Todd, 34 years, frequent OSH patient. Todd later taken into custody by Salem Police Department.

3:00 p.m., contacted Guardian Angel, Western Director John McKeim. He related that Curtis Sliwa was being arrested for an incident of protest at the Portland Rajneesh Hotel and would be unable to keep the 4:00 p.m. appointment with me. We had a lengthy discussion concerning Guardian Angel involvement in the Rajneesh problem and he changed from initial rejection to advising that he will discuss with Sliwa the possible removal of their members from Antelope and cancel the Sunday demonstration at Salem. He made two allegations against troopers at Rajneesh. These were checked, found erroneous and he was recontacted with the facts.

About 6:00 p.m., Bend advised that 10-11 street people were en route to Madras from the ranch. All but two had tickets.

9:05 p.m., Gerry Thompson advised she had a call from K.D. Very angry about Portland Police Bureau alleged mishandling of the Guardian Angel incident at the Rajneesh Hotel.

November 4, 1984

At 11:35 a.m., Guardian Angels congregated in Portland and five vehicles with 17 persons left southbound. Arrived at the Capitol just prior to 1:00 p.m., parked their vehicles and constructed a mock coffin which they covered with the flag and commenced a march. Eventually marched to the Governor's residence for protest demonstration. Four were arrested for trespass when they entered the Governor's yard.

At 1:00 p.m., Rajneesh reported 19 street people being transported to Portland; five have bus tickets, 14 without.

November 5, 1984

Captain Davenport advises that we interviewed 39 street people in Portland (Rajneesh reported 19 were coming out). Two had plane tickets to Puerto Rico and 3 had bus tickets. They relate that 3 busloads will be taken out today and by the weekend almost all street people will be out of Rajneeshpuram.

Bob Oliver advises information from Gary Kopperude that Sheela's bodyguard, Captain St. James Roy Davis III, has defected and is now at CEG office, 212 E. 4th, The Dalles, 296-2022, for interview. The Dalles office will contact and interview.

Major Lamkin advises there is a Planning Commission meeting at The Dalles Courthouse tonight. Rajneesh advise they will have 6 in attendance.

On November 6, K.D. and Sheela will attend the oral arguments before the Supreme Court in the 1000 Friends suit against the Rajneesh. Justice Peterson had previously requested security and we will assign 4 members.

Lt. Snyder, Bend, has been advised by Moses, Rajneesh legal staff, that they have petitioned Wasco County to allow 2 Rajneesh observers in each of the 19 precincts. Greg McMurdo advises he was aware of the request.

At 5:30 p.m., Rajneesh reported bus of 20 homeless en route to Madras, 19 with tickets, one without.

St. James Davis was interviewed and appears mental, has numerous aliases and lengthy criminal record.

Superintendent and I attended a meeting with Gerry Thompson, Military, and PUC regarding possible effects on communities and handling of street people release if they continue or escalate.

November 6, 1984

At about 3:00 p.m., Circuit Judge Yraguen denied Rajneesh petition to observe voters at the precincts.

Sue Proffit's home in The Dalles was burglarized last night, Sheriff's Office investigating. Appears coins were taken.

Several Rajneesh are demonstrating near the Rajneesh precinct (county shops) by chanting, etc. Are not interfering with voter access but have been directed to stay outside the specified distance of 100 feet.

Twenty-seven hearings officers are in The Dalles Armory to handle several voter registrations challenged by the Rajneesh.

ATF advises that they have documented purchases in October by the Rajneesh:

4 Galil .308 semi-automatic rifles

90 magazines (20 or 32 capacity)

18 Uzi semi-automatic rifles

30 magazines

2000 rounds .223 2000 rounds .308

In addition, 8 more Galil rifles have been ordered.

Eight street people were transported to Portland. Only two have bus tickets.

November 7, 1984

About 1:00 p.m., Rajneesh reported 13 street people en route to Portland, two have bus tickets.

Rajneeshpuram Peace Force request crime lab to inspect a package containing meat, which appears to contain white powder. Meat was received in the mail.

November 8, 1984

No Guardian Angels have been observed at Rajneesh the past two days. Captain Noland was alerted to news articles reporting the Guardian Angels plan an air drop of leaflets at Rajneesh during the Bhagwan's daily drive. Also alert for any other activity.

Portland investigators interviewed the 13 street people last night. One imposter was identified by Salvation Army. Subject had not been to Rajneeshpuram but tried to pass himself off to obtain transportation. These people estimated five to six hundred street people is all that is left at Rajneeshpuram (we believe about 2000). About 70% of those left want to leave. They further advise that the Rajneesh are starting to dismantle tents and departing street people have been advised by Rajneesh not to talk to police.

3:00 p.m., contacted Captain Noland who advises that two Guardian Angels have shown up and are in the trailer on Cold Camp Road.

Mike Sullivan relates that in a conversation with Jay Ananda he was of the opinion that the "man camp" will not be used for street people but will house regular Rajneesh and the street people will be held in Rajneeshpuram.

At 6:55 p.m., was advised that Rajneesh report 15 street people en route to Madras, 4or 5 without tickets.

November 9, 1984

No reports (Later determined that Rajneesh reported 14 street people en route to Portland. Ten with, 4 without tickets.

November 10, 1984

Teletype at 3:50 p.m. reporting Rajneesh advise a van en route to Madras with 7 street people, 5 with and 2 without tickets.

November 11, 1984

Teletype at 2:54 p.m. information from the Rajneesh that a bus left at 2:30 p.m. with 12 people en route to Portland. Six with and six without tickets.

November 12, 1984

Two conversations with John McKim, Guardian Angels, today. He initially inquired about FAA regulations and Oregon law relative airdrop of leaflets over Rajneeshpuram. Conversation then that street people were being brought out and dumped without our knowledge. Said he would try to find some for our interview.

November 13, 1984

Guardian Angels announced two press conferences: 1:00 p.m. at the Rajneesh Hotel, Portland, and 3:00 p.m. at State Police Headquarters. John McKim said they would be outside our building.

Captain Noland advises count of street people still at Rajneesh-puram by Ma Prem Sunshine is 2,000 Rajneesh; 2,000 paid visitors and 2,000 street people; total 6,000.

Curtis Sliwa with two street people visited me at General Headquarters about 4:30 p.m. Inquired about the littering laws and penalties. Was very quiet and polite.

November 14, 1984

Captain Davenport has information from Washington State Patrol that the Rajneesh have purchased 10 acres in a development area near Goldendale.

Guardian Angels announced they will airdrop leaflets at Rajneeshpuram tomorrow afternoon and then plan on blocking the county road on Saturday.

Rajneesh report 12 street people en route to Portland. Four with and 8 without tickets.



November 15, 1984

KEX Radio has been running announcements that the homeless population in Portland is about 2,000, a 20% increase because of influx of Rajneesh street people. We have determined this information came from Michael Stoops. Short investigation concluded that there are only 5-10 ex-street people in Portland. KEX was notified and will omit the Rajneesh reference as cause.

At 9:33 a.m. on Highway 26, mile post 35, a member cited Louis Raymond Velazquez, 8-15-51, of 1737 S.W. Madison Street, Portland, for 80 mph. Stated he is the Portland Guardian Angels director. Curtis Sliwa was asleep in the back seat and both very tired. Were operating a rental bronze '80 Malibu, 4 door, CSK889. Stated they were returning from Rajneesh.

Five Guardian Angels appeared at the capitol about 11:30 a.m., requested an audience with Norma Paulus, who refused. They will meet with Greg McMurdo at 1:00 p.m.

Captain Noland advises K.D. says he does not know when the "man camp" will be utilized nor by whom.

November 13, 1984

November 27, 1984

Wasco County cancelled their planned trip into Rajneeshpuram. May go at a later date.

Attempts to obtain population count and other information from Ma Sunshine and K.D. have met with negative results. Major Lamkin advises that the Rajneesh lack of response is growing.

We believe all non-Rajneesh have moved from Antelope. Bill Dixon is still the postmaster but now resides out of town.

November 28, 1984

Ma Anand Pathika, formerly Jan M. Wilson, born in Chicago, Ill. 3-28-53, married to an Italian, Geovanni Crotti. She has a B.A. in Anthropology, M.A. in Education., is the City Treasurer in Rajneesh. Reportedly is in the 2nd layer of promanence, below Sheela. She was in the legal department.

Pathika is listed as a Peace Force Reserve, but within the past two weeks has become a figure of authority in the Peace Force, appearing to displace both Ma Barka and Ma Prem Sono.

Lt. Renfrow advises that last night a school bus driver at The Dalles observed a Toyota parked between some buses at the bus barn. A female dressed in Rajneesh type clothing came from behind some of the buses, said they were trying to locate Mt. Hood Street. After they left the bus driver found several bags of sugar and one bus with the gas cap removed. Dan Durrow, Wasco County Planner lives on Mt. Hood Street. The Toyota is registered to the Rajneesh. Wasco County Sheriff's Office is investigating.

Captain Noland advised today they will set up a traffic check on Cold Camp Road and then move it to Muddy Creek Road. Will check all vehicles. Check to start at 11:00 a.m. today and will last for 3-4 hours. Will use members from The Dalles, Madras, and Bend. Will have 6-7 troopers and 2 Sergeants.

November 29, 1984

Members held a checkpoint inspection on Cold Camp Road yesterday. Several Rajneesh vehicles were checked but no citations issued. K. D. called concerned and questioned why. Explained this was routine and held throughout the state.

November 30, 1984

Twenty street people departed for Madras, four without bus tickets.

December 1, 1984

No report

December 2, 1984

Teletype reporting that at 4:45 p.m., K.D. advised the Bend office that $2\frac{1}{2}$ hours ago 6 street people departed for Portland, four without tickets. Another bus will depart about 5:15 p.m. for Madras with 17 street people, of which 4 have bus tickets. Jim Coppedge of Madras Harvest Mission was inquiring if we had been informed that no street people would depart between December 5 & 15 because of the Festival. Coppedge's home is 475-6059 and church 475-2150.

December 3, 13984

Teletype at 2:27 p.m. advising that 24 street people departed for Portland about 2:00 p.m., 9 or 10 have bus tickets.

Captain Noland met with K.D. today. K.D. promised to continue to cooperate with notification of street people departures. Would not or could not answer several questions concerning population, man camp, cooperation with Peace Force and other issues. Did complain at length about State Police lack of cooperation and concern.

At 6:40 p.m., advised by communications that 9 street people were en route to Madras, of which 8 have bus tickets.

December 4, 1984

Lt. Howland advises 15 street people were interviewed at Portland last night. No new information was learned. Recently 3 plane loads of European appearing Rajneesh arrived at the ranch, reportedly for the December celebration activities. Rumor that the Rajneesh recently purchased the large Disney Ranch near Klamath Falls is being investigated.

The Wasco County Sheriff's Office has declined our assistance investigating the November 28 report of possible attempt to sugar gas tanks of The Dalles school buses. Last night 2 deputies contacted the Peace Force who had identified the male Rajneesh who had checked out the suspect vehicle. He related he had not left the ranch. A Rajneesh attorney advised him not to answer any further questions and he refused a polygraph examination. Wasco County Sheriff's Office additional investigation is not known.

Newspaper article dated December 2 from The Dalles reports that Wasco County Planner Dan Durrow has ruled the 640 tents at Rajneeshpuram are illegal structures and he intends on issuing citations for court action.

Eight street people were taken to Madras this evening. Two were without bus tickets.

At 6:35 p.m., Bob Oliver advised he had been contacted by Gary Kopperude, The Dalles, home phone 298-4770, who related that 4 street people were dropped in The Dalles yesterday. One stated that on Wednesday or Thursday 200 street people would be deposited in The Dalles or Madras. It was determined the 4 street people had already departed and were not available for interview. K. D. is reported "out of town" and not available. Ma Anand Patheka, Rajneesh Peace Force advised she would check and advise on this rumor. Agencies of interest have been alerted.

December 5

Ma Anand Pathika has advised Captain Noland that there is no basis for the rumor that 200 street people will depart Rajneeshpuram for Madras or The Dalles today or tomorrow.

At 12:15 p.m. teletype advising six "street people" enroute Portland, only two have bus tickets.

Teletypes sent to several agencies last night alerting them of possible 175-200 street people dump came to the attention of T.V. Channel 12 who made inquiry at both Bend OSP office and Rajneeshpuram.

Captain Noland had inquiry from 10,000 Friends of Oregon (no part of 1,000 Friends of Oregon) who are apparently affiliated with the Guardian Angels. Inquiry indicated a possible large caravan - 500-1,000 - car drive through the Ranch on December 7. Guardian Angels attendance at Antelope is sporadic. They earlier indicated they would block Cold Camp Road on December 7. Their caravan may be in lieu of blockage. We will have extra patrol coverage during the celebration.

December 6

Captain Noland advises that Ma Isabell estimates about 1,200 street people still on the Ranch. Visitors for the Winter Festival are arriving and about 1,500 are expected. Some may be housed in homes in Rajneesh but not the "man camp."

Leonard Steiman, a Bend businessman, is the spokesperson for the 10,000 Friends of Oregon. He indicates that they plan a caravan to Rajneeshpuram on Sunday, December 8, to coincide with the Baghwan's daily drive. An organizational meeting will be held in Bend tonight and Lt. Renfrow will attend.

Teletype at 5:21 p.m. advising one street person enroute to Madras, has a bus ticket.

December 7, 1984

K. D. called Major Lamkin reporting that the Guardian Angels were yelling at Rajneesh vehicles that passed their observation trailer on Cold Camp Road.

About 12:30 p.m. approximately 12 Guardian Angels accompanied by news media travelled to Rajneeshpuram. Four or five laid down on the ground on the private road near the mall. Rajneesh Peace Force asked them to move and they did without incident. Guardian Angels moved to the dam area and laid down on the county road. Seven were arrested by the Peace Force and transported to The Dalles. The remainder of the Guardian Angels departed the ranch.

Teletype at 3:04 p.m. advising that at 2:30 p.m. we were notified that 10 street people departed the ranch. Five with and five without tickets.

The 10,000 Friends of Oregon will have a small caravan into Rajneeshpuram on Sunday. They have engaged Dennis Lewis, Bend, a private security operator to escort them. We will have extra patrol coverage in the area.

December 8 - NO REPORT

December 9, 1984

The 10,000 Friends of Oregon had 18 vehicles and approximately 50 people in a caravan to Rajneeshpuram. Entered the ranch at 1:30 p.m. and departed at 4:30 p.m. No incidents occurred. December 8, Leonard Steiman went to Rajneeshpuram to advise them of the 10,000 Friends plans and was cited by the Peace Force for 1 headlight.

January 1, 1985

No reports

January 2, 1985

Captain Noland advises there is no Guardian Angel activity at Rajneesh. The one member left has now gone to work for a local rancher. The trailer is still parked along Cold Camp Road, however.

January 4, 1985

Captain Noland advises the Rajneesh are conducting a weapons demonstration for the news media today. Sergeant Jack Rogers, The Dalles, will attend.

Only three of the seven Guardian Angels arrested at Rajneeshpuram appeared in court on January 2. the cases were set over until January 7 and all seven directed to appear.

Major Davenport advises 8 street people arrived in Portland last night about 8:00 p.m. Three had tickets. This is the first instance since October 20, 1984 that we were not notified.

Sergeant Rogers advises that the Rajneesh weapons demonstration today was conducted by 35 members of the Security Force. There were none of the Peace Force in evidence. Demonstration consisted of use of 10 Uzi semi-automatic rifles; 10 Galil rifles and 10 .357 revolvers. There were about 15 reporters in attendance which included television.

January 5, 1985

At 3:21 p.m., Capitol Security advised that two Guardian Angels placed a recruiting notice on the bulletin board near the cafeteria and departed.

January 6, 1985

Teletype at 2:30 p.m. reported bus loaded with 17 street people en route to Portland. Bus was stopped by a patrol but destination, other than Portland, or purpose not learned.

None contacted Salvation Army at Portland, so the trip was probably for purpose other than departure from Rajneeshpuram.

January 8, 1985

Decision has been made to reduce the number of temporary troopers at The Dalles and Madras from 10 to 3. All three temporary assignments will be at Madras. This will permit 24-hour patrol coverage in the Madras-Shaniko-Rajneesh area. Adequate patrols on Highway 97 will be provided by Madras, The Dalles and Bend.

January 8, 1985 (Continued)

We will also return the communications motor home to Salem. This will permit installation of additional equipment, including radios. In the event of indications of unrest or other problems at Rajneeshpuram, we will evaluate for added temporary personnel and/or equipment.

On January 3, 1985, Ma Anad Sheela was interviewed on Channel 6. Reportedly she indicated that next summer the Rajneesh will import prostitutes as part of their homeless project.

February 14, 1985

On February 14, 1985, a member of the Portland office interviewed four individuals who had recently arrived in Portland from Rajneeshpuram. This contact was made at the Harbor Light Mission in Portland. Three individuals had arrived on February 12, and one individual had arrived on February 13. All were transported to Portland by the Rajneesh transportation system. Three had left the ranch for personal reasons, and the fourth was told to leave because they felt he needed a change. All were in agreement that the number of estimated individuals from the street people program who remain on the ranches is between 75 and 125.

March 5, 1985

We have received information that on February 23, 1985, the Rajneesh commune purchased the listed amounts of ammunition:

5,000 rounds .223 caliber 1,000 rounds .3006 caliber

They have also expressed an interest in purchasing tracer ammunition in calibers .223 and .308. They have also requested an additional 5,000 rounds .223 and 5,000 rounds of .308.

In September, 1984, the religious community of Rajneeshpuram began a "Share A Home" program for the homeless citizens of the United States. As the result, the Salvation Army in Portland and The Dalles began a program called "Operation Love," in which the homeless from Rajneeshpuram were being sent back to the towns from which they were recruited by the Rajneesh. The program ran from October 12, 1984 and concluded on February 14, 1985. The Salvation Army sent 584 persons from Portland and 87 persons from The Dalles to their original locations. The cost of "Operation Love" was approximately \$100,000 and included expenses for bus tickets, food, lodging, and miscellaneous items for the Rajneesh homeless.

At the present time, it is estimated there are 75 to 125 homeless people at Rajneeshpuram. These people have been placed under the Rajneesh humanitarian trust program.

November 14, 1984

11/8 4:30 p.m.

Pankratz called.

In conversation with Mike Sullivan Jay Annanda hinted they aren't going to use the man camp for street people. They will use that for regular Rajneeshees and keep the street people on the ranch. Pankratz said they will be talking with K.D. about that.

Talked with K.D. this morning. Informed him of the GA proposed drop of leaflets. K.D. wasn't aware of that and was appreciative of the information. Pankratz said they told him we wanted to be sure we were aware of any exits from the ranch to avoid any confrontation with GAs, and K.D. assured we would be notified.

If the GAs do use the crop duster, the best law is FAA regulation that covers this activity which could jeopardize a pilot's license. You can't drop any article out of an aircraft without a permit and crop dusting planes can't fly over a populated area. FAA says they can jerk a pilot's license for that --

There are two GAs in the camp -- showed up mid-morning.

No reports today of anybody coming out.

November 16, 17, 18 No report

November 19, 1984

Rajneesh Peace Force report an aircraft flew over Rajneeshpuram this afternoon dropping leaflets. They relate they did not obtain the aircraft identification. They believe it was below 500 ft. altitude. Newspaper articles relate the Guardian Angels were responsible and 5,000 leaflets were dropped.

November 20, 1984

Teletype reporting that at 4:10 a.m., Rajneesh Peace Force related Guardian Angels were yelling and screaming in Rajneesh and a black Guardian Angel "mooned" the Peace Force. Trooper Buckman responded shortly after and all was quiet.

Paul Burke, Oregon Aeronautics Board, called requesting information on the Rajneeshpuram leaflet air drop. We had checked local airports with negative results. Rajneesh Peace Force recontacted and no more information obtained.

Guardian Angels held a meeting in Redmond last night. Two State Police and 150-200 persons in the audience. Curtis Sliwa conducted the meeting - anti-Rajneesh theme and criticized the Governor, Attorney General, and State Police. Announced a protest with signs and crosses for 1:00 to 2:00 p.m. today at the junction of Highway 218 and Cold Camp Road. Two members observed and only 3 Guardian Angels attended and no activity was taken by them.

Assistant Chief Sono, Rajneesh Peace Force, called Major Lamkin to complain about an Oregon State Police patrol vehicle parking on private property last week. Sr. Tpr. Gates had parked near the city hall. She stated that parking or driving off the county road was only allowed if permission is obtained. Major discussed the complaint with K.D. and will submit a report for the Attorney General's information.

11/21 2 p.m.

Pankratz: 19 street people enroute to Portland by bus; two, three with tickets. inspector from Wasco went into Rajneeshpuram at 10:15. Haven't heard back from him yet.

November 21, 1984

Major Lamkin advises the Wasco County Planning inspectors will be entering Rajneeshpuram today for follow-up inspection. They were accompanied by a Deputy Sheriff and entered the Ranch about 10:15 a.m. We have a patrol in the area. At 2:40 p.m., Wasco County said they had not heard anything from their people and asked us to check. We have a car in the immediate area and he will check and advise. Subjects were located about 4:30 p.m. Had been on a remote section of the Ranch and farm tractor-trailer accident blocked the road for nearly 4 hours.

At 2:15 p.m. teletype reported 19 street people en route to Portland, 2-3 had bus tickets.

November 22, 1984

At 5:15 p.m., communications received a call from Ma Prem Sono, Assistant Chief, Rajneesh Peace Force, reporting receipt of two packages marked bomb inside and requested a bomb technician. She was referred to District II. Sgt. Zimmerman arranged for safe storage and will respond Friday.

November 23, 19843

At 4:30 p.m., Sgt. Zimmerman advised he had checked the two suspicious boxes at Rajneeshpuram. Both contained Armstrong brand carpet type adhesive. Were labeled to the Rajneesh at Portland and someone had written "Bomb" on the side of the boxes in felt tip pen. Both had a purchase order number. Sgt. Zimmerman has the evidence for follow-up investigation.

This afternoon a commercial van truck-trailer ran off Cold Camp Road, $2\frac{1}{2}$ miles outside of Rancho Rajneesh. Rajneesh Peace Force requested our assistance. Trooper Allen responded. Truck contained 3 Rolls Royce cars en route Rajneeshpuram. Driver had been taken to Rajneeshpuram Medical Clinic and Trooper was not permitted to go there. Driver was returned to the security office and Trooper interviewed him. Reserve Officer Ma Anand Pathika complained because she was not permitted to attend the interview which took place in the Trooper's patrol car. Trooper was not permitted to inspect the Rolls Royce vehicles for damage. Driver was cited for No PUC.

November 23 (continued)

November 24, 1984

7:15 p.m., Lt. Snyder called to report a conversation with Ma Anand Pathika and K.D. Pathika called the Bend office to complain of rafters on the John Day River shooting guns and wanted an officer. He explained that this is normal hunting procedure and we would not send an officer. Additionally he explained the law requirements for trespass. Pathika later called advising that the hunters were contacted and one who was holding a shotgun stated "Oregon would be better off without you" (referring to the Rajneesh). Subjects then left and camped downriver, off the Rajneesh property. Pathika wanted an officer to contact and cite the hunters for trespass.

We refused. K. D. then called Major Lamkin and said he was going to the Governor because of our failure to act.

November 25, 1984

Teletype advising that 9 street people are en route to Portland, two have bus tickets.

November 26, 1984

Captain Davenport advises that 10 street people, 8 of them with bus tickets, came into Portland on November 23. We did not have notice from the Rajneesh. These and the 9 on Sunday relate there is more pressure for the street people to leave. Cigarette ration has been eliminated and food service has decreased. Increased pressure to work. They estimate about 300 street people are all that remain in Rajneeshpuram.

November 26 (continued)

Major Lamkin advises that on November 27 about 4 Wasco County vehicles occupied by planners, surveyors and deputy sheriffs will go to Rajneeshpuram for inspections. Bob Muir of the Attorney General's office will accompany. We will have a car in the area.



December 16, 1984

Rajneesh are transporting 11 street people to Portland. "Six have bus tickets, two with plane tickets, and 3 without tickets.

December 17, 1984

Guardian Angels are occasionally in evidence but all activity is very quiet.

December 19, 1984

Eleven street people departed Rajneeshpuram at 1:30 p.m. en route Portland. Four have bus tickets.

December 23, 1984

About noon 11 street people were transported to Portland. All have bus tickets.

Military advises they will be removing some of the "special equipped" vehicles and possibly riot gear from the Redmond area to Camp Withycombe. The equipment can be returned to Central Oregon on short notice if needed.

December 24 & 25 - No reports

December 26, 1984

Lt. Snyder, Bend, advises he was notified by K. D. that a bus with street people was leaving but would not tell him how many people or destination. K. D. advised that the Rajneesh would no longer provide such information because we are interviewing the departees and will use what we are told in a lawsuit against the Rajneesh.

Portland State Police had information that 18 persons were in the group but were able to confirm only 8, some had bus tickets.

Last population count provided to us was 950 street people on December 18.

December 27-28-29 & 30 - No reports

December 31, 1984

Captain Noland advises he is continuing discussions with K. D. for reporting departures of street people. K. D. sounds agreeable but is apparently being pressured by others in the Rajneesh hierarchy.

December 31 (Continued)

We will commence stopping loaded buses, vans, etc. in an attempt to determine if they are transporting departing street people.

Military is "standing down" their alert. This will involve moving some equipment such as vehicles and riot gear from Redmond to Camp Withycombe. Response time for an emergency may be slightly longer.

December street people recorded departures were 69, 39 with tickets, 30 without.

Since October 20, we have recorded a total of 830 departures, 364 with tickets. We estimate about 2,000 total departures.

Last count of street people given by the Rajneesh was 950 on December 18. K. D. advises the actual count is difficult because many have converted to Sannysins.

January 20, 1985

Eight street people were transported into Portland. Four had transportation tickets out of the area. This group of street people claims there are approximately 14 to 100 street people left at Rajneeshpuram.

District I is checking a report that Larry's Sport Center, Oregon City, sold several semi-automatic weapons and a quantity of ammunition to the Rajneesh.

January 22, 1985

We have received confirmation that Rajneesh Neo-Sannyas International Commune has purchased the following amounts of ammunition. Delivery of the ammunition has been made.

1. GENERAL SITUATION

In only one week the complexion of the Rajneesh situation has almost totally changed. While the potential for election day confrontation is still possible, it is considered unlikely. Rajneesh handling of the remaining street people is now surfacing as the primary concern of local authorities. The situation is changing from one in which law enforcement has the primary lead to one of emergency relief operations. In either case the National Guard could become involved early-on because of the sheer number of people involved.

2. ACTIVITIES

- a. Curtis Sliwa and his Guardian Angels conducted demonstrations in Portland and Salem and received the appropriate familiarization with Oregon law enforcement procedures for their effort. The Guardian Angels are gathering their desired media exposure but are little more than an entertaining, diversionary nuisance.
- b. The no-show of Rajneesh voting registrants on 1 and 2 November in The Dalles would indicate 6 November should be quiet. An attempt to overload the system could still occur, as registration will continue through 062000 Nov 84.
- c. A birthday celebration is scheduled in Rajneeshpuram during the period 07-11 Dec 84. Rajneeshees from all over the world are expected. Up to 15,000 may attend which may jeopardize the residency of the remaining "Street People", whose numbers are estimated to be 2,700 at this time.

3. WEATHER

Rain is expected through 08 November with freezing rain possible in higher elevations overnight.

4. CONCLUSIONS

- a. Election day will pass without confrontation in The Dalles.
- b. Rajneesh representatives will continue to challenge the registration and voting process through legal channels in The Dalles.
- c. Potential for Guard involvement in a civil disturbance role diminishes substantially at 062000 Nov 84.
- d. Potential for Guard assistance in an emergency relief role increases dramatically at 062000 Nov 84.

1. GENERAL SITUATION

Tension surrounding the registration/hearings of Rajneesh "Street People" in The Dalles continue to ease. Leaders in Rajneeshpuram were announcing on 30 and 31 October that a "Boycott" of the registration process could occur. Indications were that the transportation system in Rajneeshpuram would not be disrupted to move Rajneeshees to The Dalles for the scheduled hearings. fact, none of the Rajneeshees appeared at the Armory in The Dalles for hearings as of 011545 November. Hearings are scheduled to resume at 1900 hours and again tomorrow. Whether this is a "Boycott" seems immaterial. 800 Rajneesh were scheduled for hearings on 1 November and 1900 in The Dalles Oregon on 2 November. Indications are that leaders of the Rajneesh will challenge the procedure in the courts rather than adhere to the hearings process as established by the Secretary of A no-show on 1, 2 November should not be construed as an end of the threat. An attempt to overload the system on Election Day, 6 November, could yet occur.

2. ACTIVITIES

a. Ground. Task Force Serenity will attempt to verify the existence of Ashwood Road between Madras and Rajneeshpuram. All maps indicate a road, but locals say otherwise.

b. Air. Aerial photo reconnaissance was conducted today as a training mission with the concurrence of the Rajneesh Peace Force.

c. Other.

(1) The last of two potential Rajneesh write-in candidates for the Wasco County Commission announced that she would not participate in the election in any capacity.

(2) The Bhagwan Shree Rajneesh has broken his vow of silence. This act has generated substantial excitement in Rajneeshpuram and seems to have attracted media attention to the religion rather than politics.

(3) Curtis Sliwa of The New York - based "Guardian Angels" appeared in the Portland area on 31 October. His efforts are reportedly an honorable attempt to assist the "Street People". His arrival is ill-timed and could fuel the situation unnecessarily.

GENERAL SITUATION

There is an uneasy calm associated with the situation on Wasco County. The election day confrontation did not materialize and so far there has been a relatively small discharge of residents daily from Rajneeshpuram. Even the likelihood of Guard involvement in emergency relief operations now appears somewhat remote. The "uneasiness" comes from the knowledge that an unexpected or irrational act could yet occur causing a return to the highly emotional environment of only a few weeks ago.

2. ACTIVITIES

- a. ANNEX J (Emergency Assistance to Local Authorities) to OPLAN 01-84(Operation Serenity) was issued on 6 Nov 84.
- b. The Guardian Angels dropped about 5,000 leaflets over Rajneeshpuram today. The leaflets were dropped from a small, unidentified civilian aircraft around noon. The leaflets are protesting the release of "Street People" by the Rajneesh. The Oregon State Police (OSP) and Federal Aviation Administration (FAA) are investigating.
- c. The new housing construction in Rajneesh (Antelope) is nearing completion. Oregon State Police (OSP) reports that Rajneeshee "Sannysins" will be moved into the housing, not the so-called "Street People".
- d. Local authorities and relief agencies in Jefferson and Wasco Counties can each handle (support) a discharge of about 200 street people.
- e. There continues to be no indication of any mass exodus of people into local communities near Rajneeshpuram.
- f. About 5,000 visitors to Rajneeshpuram are expected from around the world for the Rajneesh birthday celebration during the period 7-11 December 1984.

3. WEATHER

Dry through Thanksgiving Day. Showers returning Saturday, 24 November. Temperatures moderate through 6 December with lows 25-35, Highs in 40s.

4. CONCLUSIONS

- a. Potential for Guard assistance remains a possibility through 12 December 1984. Likelihood of involvement will diminish further when The Guardian Angels depart the area.
- b. Emergency relief tasks may include transportation, shelter, feeding, and medical assistance. A tailored and reduced Task Force would be required in this role.
- c. Task Force remains at CIDCON 5. STARC HQ continues at CIDCON 4.
