findings of campaign costs in the state ought to send shock waves throughout the electorate.

The price of politics is going up drastically, dramatically and

quickly.

Consider the governor's race. In 1974, Vic Atiyeh spent \$322,607 and Bob Straub \$215,781. That seems like a lot of money, even for a statewide race in Oregon. But look at 1978. This time Atiyeh spent \$658,853 and Straub \$529,680. The price tag for gubernatorial electioneering had doubled.

But even those part-time legislative seats are getting awfully expensive. Candidates for the 60 House seats doled out \$1,715,092 in 1978, or an average of \$14,440 for every serious candidate (those who filed, but spent less than \$500 were not included). Just two years earlier, the average was about half -\$7,659, which is still a heaping amount.

*Senate races also doubled in cost in two years, from an average of terests to nurture.

Oregon Common Cause's recent \$8,281 to \$15,890. The 15 races in 1978 cost more than half a million dollars total.

The cost of campaigns in short is rapidly getting out of hand. Far too much money is being spent for the health of what has been a clean political system.

The higher the costs go, the greater will be the potential influ-ence of the special interests that are called upon to bankroll the election process. It is far too much to expect them to put up the volumes of money strictly out of a sense of civic duty.

Past efforts to hold down the cost of campaigning by placing legal limits on expenditures have been thrown out by the courts.

But the cause must not be abandoned. More and more, the evidence mounts that some type of public financing of campaigns holds out the best prospects for freeing the political process from the hazards of high campaign costs financed by a few high rollers with special in-

Governor Victor Atiyeh today announced the appointment of Mr. Noble Deckard as Acting Administrator of the Executive Department Personnel Division.

Mr. Deckard has been head of the Special Studies section of the Division since 1972.

The Personnel Administrator position became vacant when Richard Burke resigned to accept appointment as the Legislative Fiscal Officer.

Governor Atiyeh has requested that the Employment Relations Board conduct the competitive examination for permanent appointment to the position of Personnel Division Administrator as required by statute. The Governor will consider a list of qualified persons as submitted by the Employment Relations Board and submit one of these names to the Senate for confirmation.

In requesting the Employment Relations Board to conduct the necessary examination, Governor Atiyeh reiterated his belief that there are competent persons within state service that should be considered for this important management position.

A permanent appointment to fill the Personnel Division Administrator position hepefully can be made within two months.

Fred D. Miller, 36, former director of the Oregon Department of Energy, will rejoin the Oregon Department of Transportation on February 1, according to ODOT Director Fred Klaboe.

Miller, currently deputy director of Western Sun, will be assistant director for administration. He replaces Don Streun, who resigned to become executive vice president of Air Oregon.

Miller, whose salary will be \$37,608, was a special assistant to the director of ODOT from 1974 to 1977, when he was named to head up the Oregon Department of Energy.

Klaboe said Miller's duties involve supervision of finance, general services, information systems, and organization and manpower services for the department. Miller will report directly to Klaboe.

Miller holds a Ph.D from Michigan State University, where his dissertation concerned the impact of highway improvements on regional economic development in Argentina. Earlier, Miller attended Willamette University, and obtained a B.S. degree in 1964 from Portland State University.

He and his wife, Janet, have two children, and reside in Salem.

TWO TRANSITION STAFF MEMBERS NAMED BY GOVERNOR-ELECT

Two members of a transition team for Governor-Elect Vic Atiyeh were announced Thursday when he named Lynn Newbry and Travis Cross to serve as interim liaison with the Executive Department and the Governor's office.

"Both appointments are only for the temporary period of transition," Atiyeh emphasized. "Both individuals have indicated a willingness to take time away from their jobs to help during this transition period. I will be naming permanent members of my immediate staff in due course."

Newbry is public affairs executive with the Medford Corporation, a forest products manufacturing company. He is a former state senator from Jackson county who chaired the legislative ways and means committee. His father, Earl, was a two-term Secretary of State. Cross, executive director of the St. Vincent Medical Foundation, is a former assistant to Governor Mark Hatfield and was transition officer for Governor Tom McCall between his election and inauguration.

In his phone call to Atiyeh Wednesday morning Governor Bob Straub suggested two positions for working with his administration under budgeted provisions for a governor-elect. Newbry will sit in with Laurence R. Sprecher, director of the Executive Department where budget preparation is channeled and Cross will work with Loren (Bud) Kramer, executive assistant to the Governor. His first appointment to his official family came Wednesday when he said Glenna Hayden, long-time administrative assistant to Atiyeh as minority leader of the state senate, would be his personal secretary. Mrs. Hayden will handle the new governor's travel and office appointment calendar. Also appointed was Marta Ann Kitchel as receptionist. Mrs. Kitchel has been the administrative secretary for the Senate Minority Caucus and legislative secretary for the late Representative Mary Rieke.

"I have a number of names under consideration for the many positions that will need to be filled," Atiyeh noted. "Moreover, I have asked that a talent bank be established for drawing upon as the need arises. I welcome any citizen's input in this regard.

"Finding the right person for the right job is one of the highest priorities during this transition period. The search must be statewide and impartial with competence and integrity as the overriding criteria."

Recent governors have appointed an executive assistant, an administrative assistant or press aid, and a legal counsel, in the immediate office. Some flexibility exists in forming other positions and their functions.

Atiyeh has been working temporarily out of his campaign headquarters at 900 SW Stark. He said he will divide his time between Portland and Salem for a while, establishing an interim office in the Capitol Mall, working in a vacation along the way. Governor Straub is currently in Arizona on vacation.

Governor Bob Straub accepted the resignation of
State Police Superintendent Robert R. Fisher today and,
after a conference with Governor-elect Victor Atiyeh, named
Deputy Superintendent John C. Williams as his successor.

Governor Straub said, "Superintendent Fisher informed me of his intention to retire December 31, 1978, a year short of his term of appointment. Superintendent Fisher has served Oregon as a superlative public servant. The quality of the Oregon State Police is a reflection of his excellent administrative qualities. He will be missed.

"It is a pleasure to announce the appointment of
Deputy Superintendent Williams on behalf of Governor-elect
Atiyeh and myself. We feel his appointment is in the best
interest of the Department of State Police and the citizens
of Oregon. Deputy Superintendent Williams has more than
32 years of experience in a wide range of state police activities
and will make an excellent appointment."

The discussion of the appointment was on the agenda of the first face-to-face meeting between Governor Straub and Governor-elect Victor Atiyeh. The thirty minute meeting was held in the Governor's office in Salem. The Governor's staff has been meeting with the transition team from the Governor-elect's office on a regular basis but Governor Straub

has been out of state since November 9.

Governor Straub termed the meeting "cordial and productive" and said the meeting was "a discussion of pending appointments and other matters which overlap administrations. Our talks were productive and we reached full agreement and accord."

Governor-elect Victor Atiyeh said, "This first face-to-face, person-to-person meeting between the Governor and the Governor-elect was very warm and productive. I am very pleased with the approach Governor Straub and his staff have taken toward the transition. It is obvious that everyone in the Governor's office is working for a smooth transition and we feel very good about that."

Deputy Superintendent John C. Williams will assume the post of Superintendent January 1, 1979, subject to Senate confirmation.

Governor-elect Vic Atiyeh has accepted appointment to two committees of the National Governors' Association. Atiyeh will serve on the Committee on Human Resources and the Committee on Natural Resources and Environmental Management. The appointments were made at the National Governors' Association meeting this last weekend in Georgia.

There are a total of 8 committees within the national association. Atiyeh was chosen to work on these specific committees because of his extensive background and experience in the areas of natural resources and human resources.

The Governor-elect has sent telegrams to Marvin Cohen, chairman of the Civil Aeronautics Board and officials of Hughes Air West in San Francisco protesting the abandonment of Air West service to the Klamath Falls airport.

Atiyeh asked that this service be extended in interest of the high level of upcoming holiday travel.

Dolores Atiyeh, the wife of Governor-elect Vic Atiyeh, has selected a Salem house to serve as their residence. The Governor and his wife will rent a house on Winter Street north of the Capitol Mall.

The governor's house is owned by the state. Atiyeh will be living in the same house rented by former Governor Tom McCall when he held the top state job several years ago.

Gov.-Elect Vic Atiyeh has asked Leonard Kunzman to stay on as as Director of the Department of Agriculture.

"He is doing a fine job," the governor-elect said in a prepared statement issued from the transition office in Salem. "I was impressed with Leonard when I worked with him on legislative matters. Innovative things have been done in the Department of Agriculture under his leadership."

Kunzman, 53, was appointed originally by Gov. Straub in 1975.

A native Oregonian he attended Oregon State University earning degrees in agricultural science and education.

The director is a farmer himself having interest in a family farm in Clackamas County and his own property north of Salem.

Governor-elect Vic Atiyeh has asked the Land Conservation and Development Commission to retain Wes Kvarsten as director of the LCDC. In a letter written to Richard Gervais, LCDC chairman, Atiyeh said he had talked with Kvarsten and they agreed on "policy matters within the LCDC."

The director of this state agency is appointed by the commission, not the governor.

The letter to Gervais said in part: "I have just completed a lengthy conversation with Wes Kvarsten regarding the operation of the department and my philosophy on Oregon's approach to land use matters. You should know that I liked what I heard and that in general Wes and I agree on policy matters within the LCDC."

In making the letter public Atiyeh expressed a desire to avoid "having another land use ballot measure in two years.

"The LCDC needs to be more sensitive to local needs and citizen input into the land use process. The existing land use law is acceptable in my mind, but we need to enforce it with a reasonable approach by LCDC officials."

In the recent campaign Atiyeh did not support Ballot Measure 10, which would have made major changes in Oregon's land use law.

"I support and have always supported land use planning in Oregon," Atiyeh said. "I have had some concerns over how our land use laws are implemented, and I am looking for greater sensitivity by the agency to the input process."

Kvarsten was hired as director of the land use department August 23, 1977. He replaced Harold Brauner. Kvarsten, 54, spent 10 years as the executive director of the Mid-Willamette Valley Council of Governments prior to becoming the administrator of the LCDC. Before that he was the director of the Mid-Willamette Valley Planning Council. He is a resident of Salem.

Governor-Elect Vic Atiyeh has asked Joe Richards to stay on as chairman of the Environmental Quality Commission. Richards had offered his resignation to the Governor-Elect.

"I have talked at length with Richards," Atiyeh said. "I believe he has the necessary background and experience to continue to do an excellent job as chairman of the commission."

Richards will continue to chair the five-member commission which sets policy for the Department of Environmental Quality. The non-paid commission is appointed by the Governor.

Atiyeh, who as a state senator wrote Oregon's clean air and clean water laws and the legislation which created the DEQ, said, "Oregon has always been a leader in cleaning up the environment, we have been way out front of the federal government in this area, pioneering in fields the federal government is just now beginning to ponder.

"Oregon has reached full mature adult status in terms of environmental policy. We should not be treated like a child by the federal government."

Joe Richards was appointed by Governor Bob Straub in 1975. Richards is a Eugene attorney. He served as a state representative in the Oregon legislature for 3 terms beginning 1965.

Bill Young has been asked by Gov.-elect Vic Atiyeh to stay on as director of the Department of Environmental Quality. Earlier Atiyeh had also asked the chairman of the Environmental Quality Commission, Joe Richards, to continue to serve as a member of that non-paid policy board.

"This will keep the environmental protection leadership together," Atiyeh said.

"It is my intent to continue my special interest in the field of environmental

quality with my repeated insistence on a balanced and common sense but persistent

approach."

Young,41, was appointed by Gov. Bob Straub in November 1976. He had been executive director of the Local Governmental Relations Dividion of the Executive Department. He also was a city councilman and mayor of Beaverton.

The Department of Environmental Quality (DEQ) sets standards for air, water, and land quality and the control of pollution sources to maintain those standards. The DEQ was formed in 1969 through legislation sponsored by Gov.-elect Atiyeh while he served as a state senator representing Washington county.

The headquarters office for the DEQ is in Portland.

Gov.-elect Vic Atiyeh said Friday he will resign his Washington County senate seat midnight tonight (November 24, 1978), to clear the way for the choice of his successor by the Washington County commissioners.

"My resignation comes with mixed emotions," Atiyeh said. "My entire political life has been as a representative of Washington County. Now I must leave that responsibility for a new one.

"It has always been a source of personal pride to represent this part of Oregon. I am exicited about my new job and I plan on representing the whole state with the same vigor given to my legislative responsibility for the last 20 years!"

Atiyeh has been an elected member of the legislature from Washington county since 1959, serving first in the house of representatives and since 1965 in the state senate. He has been minority leader since 1973.

"It is my wish to give my successor an opportunity for the fullest and longest possible preparation for responsibilities in the senate," Atiyeh said. "She or he may well have private affairs to attend to and there is only a short period of time left before the legislature goes into session."

A formal letter of resignation was delivered to Secretary of State Norma
Paulus by Atiyeh this morning.

Another head of a state agency has been asked to stay on by Gov.—
elect Vic Atiyeh. Atiyeh has asked the Oregon Board of Forestry to retain
J. E. Schroeder as Oregon's State Forester and head of the Department of
Forestry. The request to keep Schroeder was made by the Gov.—elect after
talking with him regarding general policies and goals of the Forestry
Department.

"During my campaign for governor I proposed that the State Forestry
Department take over management of federal forest lands. I believe that
shows the respect and confidence I have for the job being done by the
department. Ed deserves credit for a responsible and efficient management
job," Atiyeh said.

The Department of Forestry directs the management of state-owned lands, provides fire protection and regulation, and administers the Forest Practices Act. The activities of this department have been used as a model for forestry departments across the country.

Schroeder, 64, was appointed in 1965 after spending 8 years as deputy director. He began work with the Forestry Department in 1941. A forestry graduate of Oregon State University, Schroeder is well-known for his reforestation leadership after the third Tillamook burn. At that time he was a district forester in Forest Grove. Schroeder is currently a resident of Turner.

Testimony by Governor-elect Victor Atiyeh before the Energy and Power Subcommittee Hearing on the Pacific Northwest Regional Energy and Power Conservation Bill

My name is Victor Atiyeh and I am Governor-elect of the State of Oregon.

I join with Governor Straub in welcoming to Oregon the Honorable Mr. Dingell of the Energy and Power Subcommittee, and his fellow members of Congress.

The means of production and delivery of electric energy in the Pacific

Northwest are a unique happenstance of history. Until recently this system was
almost wholly dependent on power derived from Columbia River hydroelectric systems.

The U. S. Government dams were the major component of that system. As of today,
however, almost half of the dams on the Columbia and its tributaries are the
result of development by non-Federal entities. We now have an extraordinary
system consisting of public utility districts, cooperatives, private utilities,
municipal electric systems and mutual associations, together with the Federal
System. These agencies have worked out cooperative mechanisms so that the
hydrosystem, in the words of Charles Luce, the former BPA administrator, is operated
as though under single ownership for maximum efficiency.

Because of increased demands, the power derived from the waters of the Columbia River and its tributaries can no longer supply the needs of the area. This has led to the introduction of high-cost thermal energy into this complex system. As a result we now have a system in which disparate costs and the consequent inequities have become a major public issue. Furthermore, the retail agencies who are dependent upon the federal system are no longer able to determine what power supplies they can expect in the future. All this has led to political tensions, lawsuits and the passage by the State of Oregon of the Domestic and Rural Power Authority (DRPA).

Activation of DRPA could be a unilateral solution to Oregon's quest for an equitable share of the region's power at an equitable price. However, I hope that we do not have to activate DRPA. What is needed is a statesman-like approach wherein parochial interests are foregone in order to attain a regional solution that accommodates all interests. I believe these statesman-like principles are embodied in the provisions of S. 3418. I recognize that this bill contains imperfections, but this is inherent in any legislation which must accommodate diverse interests. I also recognize that the bill may not yet have accommodated all interests and that further changes may be necessary. I pledge my cooperation to help you determine the final shape of the legislation.

Finally, I wish to say that Oregon is not asking for a federal handout. We are asking for our equitable share and that the federal government continue its role as a positive partner with the Northwest states. We believe the principles embodied in S. 3418 form the framework for a comprehensive legislative solution to a problem. We hope that that framework can now be built upon in an expeditious manner to reach the solution.

In 1964 Johnson was first elected to the Oregon House of Representatives and was re-elected in 1966. At the end of his first legislative session, the Associated Press selected him as the "outstanding freshman." During his two terms in the Legislature, he served as chairman of the House Taxation Committee; chairman of the Legislative Interim Committee on Highways and chairman of Fiscal Subcommittee on Education.

In 1968 he defeated a four-term incumbent for state Attorney General and was re-elected in 1972.

Johnson served as a member of the Oregon Criminal Law Revision Commission and the Governor's Commission on Judicial Reform. He served as chairman of the Oregon Law Enforcement Council and the Governor's Commission on Organized Crime, and in 1975 was appointed by the United States Attorney General to serve on the 11-member National Advisory Commission on Criminal Justice Standards and Goals.

Johnson is a member of the Oregon and California State Bar and admitted to practice before the U. S. Supreme Court. He is also a member of the American Bar Association, American Judicature Association and the Federal Bar Association.

Johnson is an avid skier, fly fisherman and a licensed instrument pilot. He plays tennis and at one time sported a 5 golf handicap.

Statement by Governor-elect Atiyeh:

"I have today decided to include as part of my 1979-81 budget a General Fund appropriation of \$5.6 million for the construction of a light rail system along the Banfield corridor. The total General Fund appropriation commitment for the project will be \$18.6 million over three bienniums. Above all, my approval of this project is contingent upon the agreement by several units of local government and the state Department of Transportation for a comprehensive program to improve transportation throughout Oregon. Indeed light rail is only a portion of a single large project for the Banfield corridor in Portland which will cost \$161 million. That project includes widening of the Banfield freeway, removal of buses from the freeway and a light rail system to be owned and operated by Tri Met. In addition, the program includes:

- The City of Portland's withdrawal of the I-505
 Interstate project. (\$178 million)
- 2. The construction of the Sunset Highway--217 Interchange. (\$12.7 million)
- 3. Improvement of Highway 212 in Clackamas County. (\$6 million).
- 4. Improvements in 190th and S.E. Powell in Gresham. (\$2.1 million)
- 5. An agreement to transfer certain federal funds for eight years from the metropolitan area to be used in highway

carried

projects throughout the state. (\$34.5 million)

As I have stated publicly in the past, it was my view that the proposed Mt. Hood Freeway was a better solution to the metropolitan transportation problem and that I had reservations about light rail as an alternative. However, local governments in that area together with Governor Straub decided to cancel that project in 1975. I am now convinced that under federal law the Mt. Hood project cannot be revived. I have examined the remaining options. I am convinced that under the circumstances this program is the only feasible alternative to solving the metropolitan transportation problems and provide federal funds for needed highway projects throughout the state.



Statement by Governor-Elect Atiyeh

One of the most important transition activities in the last few months has been the development of a budget for the next two years. My budget reflects two dramatic elements:

First of all the growth in the state's level of expenditures will be less than the rate of inflation, with a rise of 8.3% each year rather than the 25% and 27% increases in recent years.

Secondly our principle objective in drafting this budget was tax relief. Over 23% of general fund resources has been allocated for property and income tax relief.

My budget is not a shopping list for new government programs, but a commitment to responsible fiscal management. It is a budget based on often difficult and often heart rending decisions, because the expectations of some will always exceed what we can give.

I am asking that government not spend more, but do more with what it has.

This will most likely be the last news conference of the transition period. At this time I would like to review just what has been accomplished during the last two months.

I have to tell you all that I am proud of what has been done in so short a time.

Just a few days ago I kept my promise to Oregonians and produced a property and income tax relief package. Today hundreds of hours of work culminates with the delivery of the budget. Both of these significant endeavours were completed prior to the beginning of the 60th legislative session.

One of the most critical jobs for an incoming governor is selection of talented people to work in the administration. The quality

of these people's work will be the measure of our future success.

Twentyeight important appointments and reappointments were made in eight short weeks. Each of these individuals has superior background and experience for their assigned jobs.

I invite all Oregonians to study the achievements of the transition period. The programs and policies developed and the way in which they were created will be the hallmark of the Atiyeh administration. An analysis of the last two months should provide you a window into the future.

Finally, this would not have happened without the commitment and dedication of many people. Those on my immediate staff, state employees in all departments, and especially Lynn Newbry and Travis Cross the two top transition staffers.

"Oregonians have waited a dozen years for an antiinflationary budget, and now under the leadership of Vic Atiyeh we have one," said House Minority Leader Rep. Gary Wilhelms, R-Klamath Falls.

"This is a working-class budget that shows frugality and is in keeping with the public mandate for tax relief.

"Vital state programs are being adequately funded to maintain the high standards we have set. Yet, the administrative costs of government are being reduced, a move that all taxpayers will cheer.

"The funding for education and human resources is being increased substantially, but the programs and services these segments of state government provide are essential. Gov.-elect Atieyh is showing a deep concern for the needs of Oregon's needy and for our youth.

"The House Republican Caucus believes that government, just as private citizens and businesses, should be an equal partner in the painful process of belt-tightening. And, finally Oregon has a governor who believes likewise.

"Atiyeh's budget sends 25 percent of every tax dollar back to the people of Oregon in direct and meaningful tax relief. And, he has been able to do this by trimming and cutting budgets. There may be cries of anguish over some of the cuts, but we cannot continue to dig ever deeper into the wallets and purses of the working men and women of Oregon.

"Atiyeh's budget is a 70 percent decrease in the rate of state spending. His projections call for a state spending increase of only 8.3 percent. (Gov. Straub's last budget was a 27.7 percent increase in state spending.)

"He is able to decrease spending while maintaining the highest level of school support in the state's history. Atiyeh's decision to keep Basic School Support at 40 percent is one that should meet with the general approval of the Legislature."

Wilhelms said he is pleased with Atiyeh's decision to "improve the state's long-range timber supply through intensive forest management practices."

"This move is in concert with the rest of the Pacific Northwest. With 32% of the regional employment associated with the timber industry, Atiyeh's concern with improving our timber resource is to be lauded.

"In all, Atiyeh's budget is a sound, fiscal document that answers the public mandate for tax relief, reduced
