Atiyeh blasts McClure Un Oregon timber plan

Gov. Vic Atiyeh said Friday that he "strongly resents" it that a U.S. senator from Idaho opposes timber price rollbacks in Oregon.

"I find it unacceptable that he says to Oregon, 'You can't have jobs,' " Atiyeh said after a meeting in his state Capitol office with Robert Burford, director of the federal Bureau of Land Management.

Atiyeh referred to Sen. James McClure, R-Idaho, chairman of the Senate Energy Committee, and a supporter of pine region mill operators fighting a proposal of Sen. Mark Hatfield, R-Ore., for a 35-45 percent rollback of prices in BLM contracts. Almost all of the BLM timber is in 18 Western Oregon counties where adjusting stumpage up or down according to market fluctuations is not practiced.

The governor said Burford understood Oregon's situation, "but he has his own political problems." Burford agreed to relay Atiyeh's concern to Interior Secretary James Watt, and the governor said he will telephone Watt next week.

Burford said Thursday in Portland that the disagreement between Hatfield and McClure was "a political impasse." The Interior Department does not have authority to roll back prices or grant contract extensions, and the issue can be resolved only by Congress, Burford indicated.

Atiyeh said he also asked the BLM chief to "speed up" the process of exchanging state and BLM lands to block together more tracts for efficient management.
